SEX ED BILL PUSHES PROMISCUITY

As parents, we know we must often read "between the lines" when our children are involved in fads, movies, books, "super heroes" and unfortunately, education proposals. The latest "new and better" idea is HB 1163, a "Comprehensive Sex Education" bill that has already passed the PA House Education Committee by a vote of 14-11. It now sits in the Appropriations Committee.

This bill has Planned Parenthood's fingerprints all over it. Even the "amendments" added to the original bill are suspect. State pro-life, pro-family groups have worked hard against the bill. The new sex education will be **mandatory** for students in government schools. Students may be excused if a parent or guardian provides a written request. The "non-bias" section of the bill will inhibit instruction in some areas, and any direction in morality will have to come from home.

BOOK REVIEW



Won by Love by Norma McCorvey with Gary Thomas
Nashville, Tennessee: Thomas A. Nelson, 1997, 244 pp.

Having been published in 1997, this book is perhaps old news to some readers of this newsletter, but its message of hope in the face of overwhelming evil is ever new.

The title refers to the cause of Norma McCorvey's transformation from pro-abortion to pro-life and from pagan to Christian. Her history is a depressingly familiar one: a dysfunctional upbringing leading to drugs, alcohol, failed relationships with men, and even a lesbian phase. Used in one way by the kind of men to whom such women almost inevitably gravitate, and in another way by the obnoxious chief harridans of the abortion movement and their media lapdogs, who despised her, being used was all she knew. It is no surprise that such a severely wounded soul would be found working in an abortion clinic in Dallas, Texas, where this story begins.

But beneath that rough exterior beat a heart of gold, in that sense reminding me of the familiar madam or saloon owner character often found in western novels. It seems a fitting speculation, then, that to reach this lost soul, God devised what could have been a good plot for a novel: having Operation Rescue move into the office next to the abortion clinic. The book indeed reads like a novel. Great literature it isn't, but it is a good human interest story.

Under the Rescuers' influence, McCorvey's transformation takes place fairly quickly. Barely four months after they arrived in April of 1995, she found herself receiving an Evangelical-style baptism in a backyard swimming pool.

There is a baffling passage on page 161 that cries out for clarification. McCorvey states that her housemate, Connie, her former lesbian partner but still her co-worker at the abortion clinic, had long been trying to convert her to Catholicism. As presented, this makes no sense. We are given no prior (or subsequent) indication that Connie was at all religious; nor should we expect any, given this history. Conversely, we should expect anyone serious enough about the Catholic religion to seek conversions to be aware of the eternal consequences of unrepented homosexual activity and facilitation of abortions and to be horrified at the thought of them, let alone perform these actions for years with no apparent compunction. This offhand, out-of-the-blue passage had me doing a double-take, and it should have been flagged by an editor at the publisher. Given those eternal consequences, it cannot be overstated how irreconcilable these activities are with Catholic teaching.

The latter part of the book covers McCorvey's transition to pro-life work, and this is the book's happy ending. But only a year later, through ongoing interaction with Catholics in the pro-life movement and the timely intervention of a worthy priest instructor, McCorvey was received into the Roman Catholic Church – the supremely happy ending to what we might call God's real-life novel.

SEX VIDEO GAMES



National Institutes of Health

The Nation's Medical Research Agency

A National Institutes for Health grant for \$3.9 million is being given to Dr. Lynn Feillin, an assistant professor at the Yale School of Medicine, to develop a video game to teach “sex, drug and alcohol negotiation and refusal skills” to children 9-14 years of age. The game's effectiveness in training children to avoid “HIV-transmitting behaviors” will be tested by having children as young as nine play the game two days a week for a month. *American Family Association/3-2010*

VACCINES FROM ABORTION



During the 1964 Rubella epidemic some doctors advised rubella-infected pregnant women to abort their children, based on the fear their baby might be born with birth defects.

Working alongside these doctors, researchers collected the live fetal tissue. Ultimately they extracted the virus from the 27th aborted baby's kidney, labeling it RA273. (R=Rubella, A=Abortion, 27=27th abortion in the study, 3=3rd tissue explanted). This virus was then cultivated on WI-38 (Wistar Institute No. 38) a cell line produced from the lung tissue of a 3 months gestation female baby, electively aborted in Sweden. But prior to perfecting WI-38, there were numerous other abortions performed in the research. Ultimately, scientists documented at least 81 elective abortions to produce the rubella vaccine alone.

STAY AWAY FROM “ELLA”



We know that approval of a drug by the Food & Drug Administration does not necessarily mean the drug is safe. (*Think Gardasil or Plan B*). Now the

Advisory Committee for Reproductive Health Drugs cast two 11-0 votes saying **ulipristal**, known in Europe as ELLA, “is safe and effective at preventing pregnancy.”

Wendy Wright of Concerned Women for America, who testified at the hearings, said members of the panel ignored the fact that the drug clearly works as an abortion pill by terminating the life of a newly conceived human being. She noted that as the female panel member voted for the drug, another committee member noted the high number of miscarriages and said, “You're going to have a problem with those miscarriages.”

Wright said animal studies showed nearly all pregnancies ended in stillbirths. She said the FDA panel would not consider publishing a warning label on the drug to inform women about the potential problems or its abortifacient properties. They also strongly recommended not giving a woman a pregnancy test. They are telling doctors to be willfully blind when giving the drug. Women will be enticed by the claim that it can prevent a pregnancy, unaware that it can also end a pregnancy. European Medicines Agency (EMA) noted that ELLA “is embryotoxic at low doses.”

The American Association of Pro-Life Obstetricians and Gynecologists (AAPLOG) has concluded...that ulipristal acetate is an abortifacient of the same type as mifepristone (RU486) and that its approval as an emergency contraceptive raises serious health and ethical issues.

CASE AGAINST PP REINSTATED



The U.S. Court of Appeals for the Ninth Circuit is reinstating *Gonzalez v. Planned Parenthood of Los Angeles*, a case alleging that PP defrauded taxpayers of tens of millions of dollars by overfilling government programs for birth-control pills and similar items.

Victor Gonzalez, a former Chief Financial Officer for PP of Los Angeles (PPLA), filed his suit in 2005, shortly after he was fired allegedly for voicing concerns about PP's illegal accounting practices. Gonzales said PP had been billing California's Department of Health Services (DHS) since at least 1997 at the "usual and customary" rates for oral contraceptives rather than at the lower "acquisition cost" rates. This was despite the fact that the DHS had repeatedly instructed the PP Affiliates of California (PPAC) to seek reimbursement for drugs solely at the acquisition cost.

This means PP may have charged the DHS as much as 12 times the purchase price of some drugs.

An audit report issued by the California Department of Health Services found that such overbilling cost the state over \$5.2 million for the audit period. Some sources say CA may have been defrauded of more than \$180 million in all.

Attorneys representing PP convinced U.S. District Court Judge Howard to dismiss Gonzalez's suit in 2008 on the grounds that he was not an "original source" as the FCA requires, but Ninth Circuit Judges Goodwin, Schroeder and Fischer ordered the case reopened on July 2. The case names as defendants each of the PP affiliates in California. PP is well known for attempting to maximize profits through unethical means, such as by pushing profitable abortions and promoting chemical abortions. The CA case may start a firestorm of similar cases across the country. Let's hope it does.

DESPERATE FOR CHILDBIRTH



A region in northern Italy is offering expectant mothers as much as \$5,500 a year to overcome financial difficulties. The policy is seen as a bid to reduce the abortion death toll and to address Italy's plummeting birth rate, at 1.32 children born per woman of childbearing age. A rate of 2.1 is necessary to assure a future for a people.

Italy ranks 206th of 223 countries in fertility rates and is expecting dramatic reductions in population over the next decades. Indeed, demographic observers are predicting eventual extinction of the indigenous Italian population.

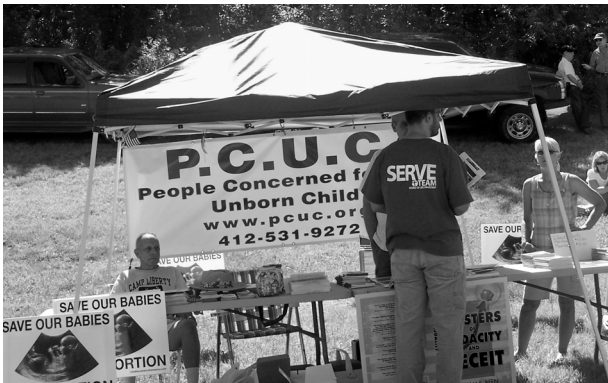

"CHOICES" HITS THE PAVEMENT

Keri Muir, executive director of Choices Pregnancy Center in Coraopolis, shared the story of the new mobile ultrasound RV which has been hitting Pittsburgh streets and bringing the best news a pregnant woman could ever hear: "You don't have to have an abortion; we're here to help."

First, they researched the idea by checking out an already successful operation in Akron, Ohio. The pregnancy care group there also has a mobile unit and through non-threatening outreach, have attained an 80-90% rescue rate for the women who have agreed to the ultrasound and have seen their beautiful children, just growing and waiting to meet their courageous mothers.

Through a fund-raising campaign that Keri characterized as "miraculous," their group has outfitted the 30' RV with an ultrasound machine, examination table, and a beautiful no-problem counseling area. The volunteers arrive at

a pre-established spot and hand out free "coupons" for an ultrasound, just in case someone knows a "friend" that might profit from seeing the truth.

So far, the RV has been seen at CCAC North Side, Pitt, the abortion "clinic" in East Liberty, Community Care in Homestead, and down the street from the "clinic" on the North Side. Right now, they're investigating how they can reserve parking spaces near Planned Parenthood downtown. Keri says: "God will establish our path."

So on the surface abortion providers may be jumping for joy with the new health care legislation, but quietly, kindly, pro-lifers continue to spread the great news: *you don't have to have an abortion*. And we know who wins the debate: good always conquers evil. Abortion is evil and will be conquered.
