NO ACTION IN HARRISBURG



Our Pro-Life Coalition of PA has a 12 point agenda, but not much action to date. The Obamacare Opt Out Bill, SB 3, was approved by the Senate Banking and Insurance Committee in January, but more than two months later, is still in the Senate Appropriations Committee. We urge you to call the chairman, Senator Corman (717-787-1377).

The Ultrasound Bill has been prepared, but not introduced. HB 383 was introduced in March, providing Conscience Protection for health care workers. "Family Planning" remains in Gov. Corbett's budget. Call and write him. Our youth need our encouragement, not condoms and pills from Planned Parenthood. Gov. Tom Corbett, 225 Main Capitol, Harrisburg, PA 17120; 717-772-9048.

You can also make progress in Harrisburg by contacting your PA Representative and PA Senator. Ask for action on the pro-life/pro-family agenda. Pre-election surveys indicate a pro-life majority in the PA House and Senate. So, let's get busy! Every day we hear of results in other states; Montana, South Dakota, Idaho, Ohio, Texas, Virginia, Utah, etc. The Keystone State should live up to its name.

PA ABORTIONS IN 2009



National analysts have focused on the use of abortion for "birth control." They illustrate that abortion caused many to become sexually promiscuous as they

had abortion as a backup to their failed contraception.

Planned Parenthood reports that 54% of women seeking an abortion were using contraception in the month they became pregnant. An awful price is being paid for this promotion of promiscuity. More than 55 million American children have been killed, and their mothers are wounded.

During 2009, 54% who aborted did so for the first time, while 46% already had aborted. Of the 46%, 25% had one previous abortion, 19% already had two abortions before theirs in 2009, 8% had three, and 5% had four or more. Source: Pro-Life Union NL, March 2011

spring. Words of encouragement from passers-by could light a dark afternoon. Epithets were endured in silence. Most difficult to bear was the seemed indifference of the downtown crowd. Surely they were touched, even if they passed by as though we were invisible.

LETTER FROM THE PRESIDENT



In the book, **The Starfish and the Spider**, the authors, Brafman and Beckstrom, tell an interesting tale.

It seems that a spider is all head and little body. The head dies, the body dies. But a starfish has enough neurological activity and

intelligence in each leg, so if there is an injury to one leg, the whole body just keeps going. And it grows a new leg if injured. Sometimes a leg that was separated from the body just grows another starfish. When all the legs agree, then it moves in the same direction and gets somewhere.

So pro-lifers resemble the starfish, all moving in the same direction to defend human life from conception to natural death. Based on the trust we have for each other, we simply keep moving. When faced with opposition in one area, we just grow stronger in another.

One often hears the complaint that pro-lifers should be more organized, more centrally located and headed by "someone in charge." Maybe. But we're all moving in the same direction. Groups wax strong and then are replaced by other groups as the need arises.

For instance, just as the pro-abortion people were celebrating the election of the most abortion-minded president in American history, Barack Obama, a new movement was gaining strength and purpose. Results were seen in about 247 cities and innumerable hearts. Realistically, the 40 Days for Life campaign should not have worked at all: no great centralized financing, no huge downtown office building, no organizational flow charts, and the members just...PRAYED! Begun by Shawn Carney and David Bereit, it grew from city to city. This Lent, it was terrific here in Pittsburgh.

Thanks so much to Nikki and Joe Bruni & Co., our city noticed people praying at Planned Parenthood and wonderful things happened. From Erie, Indiana, Ohio, West Virginia, Westmoreland, Butler, Fayette, you name the place, people sacrificed time and high gas prices to come, find a parking space, and pray at Planned Parenthood where more abortions take place than any other place in this area. 

HOPE FOR CANCER PATIENT

A four-year-old girl in Spain has been "cured" of brain cancer through the use of umbilical cord stem cells, as reported by Matthew Cullinan Hoffmann in *LifeSiteNews.com*.

Born healthy in 2007, she "began to suffer from a brain tumor" at the age of 22 months "and needed several intensive rounds of chemotherapy which destroyed her blood cells, requiring her to receive infusions of stem cells from her umbilical cord." The practice of storing umbilical cord stem cells at birth is rare in Spain, and the transplant of such cells was the first in Spanish history.

The report of success comes some "16 months after her stem cells restored her blood system, and she remains cancer free. Doctors will be able to certify her as 'cured' after [she has lived] a total of five years without a relapse."

In contrast with embryonic stem cell procedures, which destroy a human life in its earliest stages and which have never produced a single cure, adult or umbilical cord stem cell procedures are harmless to the donor and are proving to be a powerful weapon in the arsenal of modern medical treatments.



PP STATISTICS NEED A CLOSER LOOK



Planned Parenthood has told us that abortions make up just three percent of its services. Kristan Hawkins of Students for Life and Charmaine Yoest of Americans United for Life came up with very different numbers, and the SFL and AUL numbers agree.

Kristan (photo) and Charmaine used a 2010 PP fact sheet from the PP website. They provided 324,008 abortion services, 2,405 adoption referrals and 9,433 prenatal services in 2008. When calculated, abortion services accounted for 96% of the services provided to pregnant women. The math:

2,405 + 9,433 = 11,838 (non-abortion services to pregnant women)

11,838 / 324,008 = .036 = 3.6%

100% - 3.6% = 96.4% (services to pregnant women – abortions)

Abby Johnson, former PP director, recently commented on the way PP reports on its numbers to ensure that the public will not know the truth of their business: "...PP says abortions make up just 3% of its services, I found they used sleight of hand, unbundling family planning services so each patient shows anywhere from five to 20 'visits' per appointment. It does the opposite for abortion visits, bundling them together so each appointment shows as one visit. You have an overwhelming number of 'visits' for family planning compared to abortion, even though you may have seen the same number of patients.

"The fact is, PP has been caught time and time again breaking federal and state laws by protecting racists, rapists and sex traffickers of minors. Why would we trust them with accurate numbers of the abortions they provide.

"From now on, I will call them Preventing Parenthood."



According to an article at Fox News, the city of Philadelphia has begun a new campaign to engage children as young as 11 in the use of condoms.

A new website set up by the city's Health Department to promote the campaign offers, "If you live in Philadelphia and are between the ages of 11 and 19, you can now have condoms mailed directly to you for FREE. Maybe it's difficult for you to stop by one of our sites. Or maybe you're just shy or feeling weird about picking up condoms."

The free service does not require parental consent or even parental knowledge.

How is this legal? In a 1998 case regarding condom distribution in Philadelphia's schools, the U.S. Court of Appeals for the Third Circuit determined that if "the program lacks any degree of coercion or compulsion...neither an opt out provision nor parental notification is required by the Federal Constitution." *Parents United for Better Schools, Inc. v. School District of Philadelphia Board of Education, 148 F.3d 260 (1998).* Since children are not compelled to ask for free condoms, the offer by the city doesn't constitute a violation of the parental rights according to the courts.

So your child can't take an aspirin at school without a parent's letter and the consent of the school nurse, but.....

FATHER HAS NO REGRETS FOR KILLING



Robert Latimer was convicted of second-degree murder for killing his disabled daughter, Tracy. He says he has no regrets and in retrospect he would do it again. In an interview with Radio-Canada, Latimer said, "I know I was right." He was granted full parole on

December 8, 2010. He told CBC's interviewer that the decision to kill her was hard, "but it was not sad."

When Tracy's death was discovered, Latimer at first lied to police, saying that she had died in her sleep. He later confessed to police, who had done an autopsy, that he had killed his daughter by placing her in the cab of his truck and connecting a hose from the cab to the truck's exhaust pipe. Later he placed her in her bed, giving the impression to your wife and others that she had died in her sleep.

Latimer disparaged the Canadian justice system and advocacy groups for the disabled. "They're just a bunch of arrogant, self-righteous, religious-backed people. They don't care about Tracy. They're just a bunch of sadistic butchers, really. They have to come clean on that. What is the legal alternative that we were supposed to take by law?"

Alex Schadenberg of the Euthanasia Prevention Coalition commented that Latimer's remarks demonstrate, "exactly why we need laws that protect people with disabilities...precisely because some people like Robert Latimer view killing a person with a disability a merciful act."

Latimer said, "People think it's a hard question, but it's not." *Thaddeus Balinski wrote the original article 2-17-2011*

FORMER PP DIRECTOR SPEAKS

On Monday, April 18, a large crowd of students gathered on Franciscan University of Steubenville's campus to hear Abby Johnson. Abby was the director of a Planned Parenthood clinic in Texas for eight years before finally having a true conversion of heart. Her moving story is told in her best-selling book, **unPlanned**, co-published by Ignatius Press and endorsed by Fr. Frank Pavone of Priests for Life.

Abby was thrilled to be there, and the students warmly greeted Abby with a standing ovation even before she began. She shared her excitement about coming into the Catholic Church this Easter. She jokingly said that it seems to be a natural progression. "You become pro-life, and then you become Catholic." Abby began her talk with encouragement. "I believe that abortion is going to end in this country because of you, sitting right here, in this room."

One of the blessings in Abby's life was the prayer campaign known as 40 Days for life, now worldwide, but at the time, brand new. Those who prayed outside of the clinic offered their help and their prayers to Abby for years. When at last Abby made the decision to leave her position at PP, she hoped that she would find assistance from those who had offered it to her for so long. She did, and it changed her life.

After having left her job, she was praying and sidewalk counseling outside of the very facility where she had worked as director. It was awkward and difficult for her, of course, but she emphasized, "The most important thing you will ever do in the pro-life movement is to go and pray and be a witness outside of an abortion clinic. It's scary, but you do it anyway." As her talk went on, she continued to call the students to do more. At one point, she warned, "If we are not actively working to end abortion, we are complicit in it."

It was on September 26, 2009 that Abby witnessed and participated in an ultrasound-guided abortion at her clinic for the first time, after eight years of working there. It was this horrifying experience that began her conversion. Interestingly, Abby shared that Planned Parenthood does not, as a general rule, do ultrasound-guided abortions. What she participated in was a rare occurrence because, as she put it, it is "too risky. It allows people to see the truth. It exposes the abortion industry's lie."

Abby explained that no one really says that they hope to work in the abortion industry for their occupation. "But," she admitted, "as we get older and become more secular, we justify our sin." However, Abby knows that her former way of life has been forgiven. She went from being named PP Employee of the Year to "National Pro-Life Advocate" within one year's time. She has even chosen St. Mary Magdalene (traditionally connected with great sin and great repentance) as her confirmation saint, and shared that "If God can forgive a big sinner like me, He can forgive anybody."

To conclude, Abby gave one last word of encouragement to the aspiring young student body, telling them that we should be expecting people who work in the abortion industry to convert. "You never know when someone will come out running into your arms. But they can't run into your arms if you're not there."

KEY TO CANCER CURE? LOOK!

Well this is ironic: People with Down syndrome—against whom a concerted pogrom is being waged to wipe off the face of the earth via genetic testing and eugenic abortion or infanticide—may hold the key to an effective treatment for cancer.

Scientists may have solved the mystery of why people with Down syndrome seem to have a lower risk of some cancers.

The extra copy of chromosome 21 which causes Down's appears to contain a gene that protects from solid cancerous tumors, tests on mice suggest. The gene seems to interfere with signals a tumor relies on to grow. The finding raises hope of new ways to prevent and treat cancer.

Will that slow down our drive to identify and destroy these precious human beings before they can be born? Not a chance. We talk a good game of "diversity," but we don't really mean it.

BUS DRIVER FIRED FOR "NO" TO PP TRIP

A Texas bus driver who was fired for refusing to drive a woman to a Planned Parenthood abortion facility has been awarded a \$21,000 settlement, although he has been barred from seeking employment at his former position.

Kyle resident, Ed Graning, 63, filed a federal suit



against the Capital Area Rural Transportation System (CARTS) after his former employer terminated him for refusing to drive a woman to a local Planned Parenthood that he discovered performed abortions. The woman quickly received a ride from another bus.

Graning, a former pastor and grandfather of three, said that he felt acquiescing to the woman's request was irreconcilable with his Christian faith. He said, "I love the Lord, and I'm not going to be a part of something like this."

ROLE OF JUDGES IN ABORTION APPEALS

The PA Supreme Court will consider the role judges play in deciding when a minor can have an abortion. The case, *in re Jane Doe*, a minor girl asked an Allegheny County judge for permission to have an abortion after she was unable to obtain consent from one of her parents, as required by the PA Abortion Control Act. The judge denied the request and the girl appealed, but she lost again.

"Now the girl's lawyers have asked the state Supreme Court if a lower court should have done more." [Source for this statement is the Morning Call, 2-2-11]

According to Denis Brenin, Esq., quoted in the article, "giving the judges latitude to weigh facts and assess a minor's maturity is the only way the Legislature's interest in passing the Abortion Control Act can be fulfilled.

BABY SAVED USING BULLHORN We can help you!"

On March 11, 2011, at Hillcrest abortion mill in Harrisburg, Sue Doller was standing on the sidewalk in front of the building with a bullhorn. Due to the level of noise from the traffic on Front Street, Sue needed some way to get her message to women seeking abortions inside the facility.

The sound of the bullhorn penetrated the walls of the mill, and one couple, that we know of, came out of Hillcrest, hugged Sue and chose life for their baby. They thanked Sue and said they heard the bullhorn inside the mill and changed their minds. Of course, Hillcrest called the police, and they cited Sue for "disorderly conduct and unreasonable noise."

On March 30 Sue was found guilty of "disturbing the peace" in spite of the excellent testimony she presented. The judge would not allow the video of the incident to be shown in court. Sue's friend Chris Stoner is asking anyone who can help with Sue's expenses to donate to the cause. She will have to pay a court recorder \$250 plus charges for each page of the court transcript and court costs of at least \$388.50. BABY JOSEPH GOES HOME TO CANADA

Baby Joseph napping at home in his crib on Easter morning is all the proof his father needs that the London (Ontario) doctors were wrong. Only months ago, doctors at London Health Sciences Centre sought to take him off life support as the infant battled a progressive neurological disorder.

But on Sunday the round cheeked baby was home, resting in a cradle packed with plush toys in his parents' home. Now and then he opened his eyes or wriggled a little, or moved his arms beneath father Moe Maraachli's occasional touches and kisses. When dad held out a finger, Joseph's own stubby fingers curled around it.

He's breathing without a ventilator after surgery in St. Louis to perform the airway-opening tracheotomy his family sought but couldn't get in Canada as they battled to bring Joseph home to die.

No one is sure how long Joseph will live.

"That's by God and him. I never think about that," said Maraachli. "I have good faith in my heart, and my wife is the same like me, so our faith is very strong."

He is not angry at the hospital itself, but he feels he's owed an explanation for the decision to refuse Joseph the tracheotomy. *Source: The Windsor Star 4-27-2011*
