IMPORTANT BILLS PASSED IN PA HOUSE



Two bills we have been working on for most of the year have passed the PA House of Representatives. Now one must also pass in the State Senate before going to the Governor to be signed.

SB 1977 was also known as SB 3 – to exempt PA from the portion of Obamacare that deals with abortion funding. We thank

Representatives Brooks, Christiana, Dom Costa, Deasy, DeLuca, Dunbar, Ellis, Evankovich, Gergely, Gibbons, Harhai, Hutchinson, Kortz, Kotik, Krieger, Kula, Longietta, Maher, Mahoney, Markosek, Marshall, Matzai, Metcalf, Mustio, Orlander, Petrarca, Pyle, Ravenstahl, Readshaw, Reed, Reese, Saccone, Sainato, Sam Smith, Stevenson and Vulkovich. We also thank Mike Turzai for his strong leadership. Those not mentioned voted against final passage or against the two crippling amendments that the pro-aborts tried to use to defeat the bill.

In the aftermath of the Philadelphia clinic disaster, SB 732 (HB 574) passed in both Houses. The bill is ready to be signed into law by Governor Corbett. Despite overwhelming pro-life support, the pro-aborts still tried to defeat the bill with their crippling amendments. We sincerely thank Representatives Brooks, Christiana, Deasy, DeLuca, Dunbar, Ellis Evankovich, Gibbons, Harhai, Hutchinson, Kotik, Krieger, Kula, Longietta, Maher, Mahoney, Markosek, Marshall, Matzai, Metcalf, Mustio, Orlander, Petrarca, Pyle, Ravenstahl, Readshaw, Reed, Reese, Saccone, Sainato, Sam Smith, Stevenson, Turzai and Vulkovich. Gergely and Kortz were off on two of the amendments. Dom and Paul Costa were off on one of the amendments. Daley was absent for final vote but had voted pro-abortion on eight of the amendments. White and Newman voted pro-life on final passage, but Newman had voted proabortion on eight of the amendments and Newman on six. Those not mentioned voted pro-abortion.

In the Senate we thank **Kucinich**, **Orie**, **Pippy**, **Robbins**, **Solobay**, **Vogel**, **Ward**, **Don White and Mary Jo White. Please call or email your appreciation.** We are disappointed that Brewster, Jay Costa, Ferlo and Fontana voted against this basic, common sense protection for women.

What a shame that the industry that pretends to care for women's "reproductive needs" would balk and even try to sabotage a law to bring every one of their places of business into compliance with the same standards of care as any other surgical care center. It took pro-life people to do even this.

GERON STOPS STEM CELL TESTS



California-based Geron Corp., one of the most prominent pioneers in embryo stem cell experimentation said in mid-November that it is pulling out of the field. Geron cancelled the first human clinical trials

in a "therapy" using stem cells harvested from embryonic human beings. They will be out of the business altogether.

Speculations on the "why" of the pullout ranged from falling Geron stock prices to the possibility that something went wrong in the clinical trial, in which embryonic stem cells were injected into the spines of five spinal cord patients.

The move may mark the end of the entire embryonic stem cell industry—unless government invests more taxpayers' money into a goose chase from which private investors have fled. Let us pray that this is the end.

PASSING OF A FRIEND

Peter Kellett was only 6-1/2 years old when he died, but he had accomplished far more than could be imagined.

When told her baby had "markers that indicated there might be a chromosomal disorder," Peter's Mother, Mary, refused, in part because of the risk to her child of the amniocentesis and because she knew the "more choices" meant abortion.

Peter was born with Trisomy 18, a debilitant chromosomal defect. Some told his parents to wrap him in a blanket and let him die. Yet because of the courage of his parents and his own fighting spirit, Peter lived. For 6-1/2 years, Peter defied his "incompatible with life" diagnosis. He inspired his mother to found Prenatal Partners for Life prenatalpartnersforlife.org> which provides "support, information and encouragement for carrying to term with an adverse prenatal diagnosis, and support for raising your child with special needs after birth."

The presence of children with genetic abnormalities such as Peter's has become extremely sparse in our society because of the combination of *in uteri* diagnosis and abortion. Peter's brief life gave witness to the reality that although he was not "normal" and he was a "burden," he enriched lives and brought a quality out of all who encountered him. **May he rest in peace.**Pro-Life Action News 10-2011

IS OBAMACARE CONSTITUTIONAL?

In mid-November the U.S. Supreme Court agreed to consider the constitutionality of ObamaCare, particularly on



the issue of the law's mandate that every American purchase medical insurance. Plaintiffs hope to invalidate the entire Act through that issue. The law's drafters did not include a clause safeguarding the whole Act from invalidation of any one provision.

The Justices are expected to hear oral arguments in the case next spring, with

PEPS

ARE YOU STILL DRINKING PEPSI?

Debi Vinnedge, director of Children of God for Life is calling for a boycott of major food companies partnering with Senomyx.

They included PepsiCo, Kraft Foods, Solae and Nestle'. "The company's key flavor programs focus on the discovery and development of savory, sweet and salt flavor ingredients that are intended to allow for the reduction of MSG, sugar and salt in food and beverage products," the Senomyx web site says. "Using isolated human taste receptors, we created proprietary taste receptor-based assay systems that provide a biochemical or electronic readout when a flavor ingredient interacts with the receptor." Vinnedge says the collaborating companies provide Senomyx with research and development funding plus royalties on sales of products using their flavor ingredients.

"What they don't tell the public is that they are using HEK 293 – human embryonic kidney cells taken from an electively aborted baby to produce these receptors. They could have easily chosen animal, insect, or other morally obtained human cells expressing the G protein for taste receptors."

When contacted, the companies squirmed and came up with specious responses: (1) after three letters to them, Nestle' admitted its relationship with Senomyx and claimed the line of cells from abortions was, "well established in scientific research." (2) PepsiCo wrote: "We hope you are reassured to learn that our collaboration with Senomyx is strictly limited to creating lower-calorie, great tasting beverages for consumers. This will help us achieve our commitment to reduce added sugar per serving by 25% in key brands in key markets over the next decade and ultimately help people live healthier lives." (Does Pepsico think THIS tripe will end the discussion?)

sterilizations in exchange for raffle tickets. With each procedure, the participant is entered in a forthcoming drawing in which they can win prizes like a Tata Nano

car, motorbikes and electric food blenders.

Authorities in the Jhunjhunu district of Rajasthan have long operated a program of "camps" where men and women are made aware of "family planning" and told that free procedures are available. This year, officials hit upon the idea of "incentivizing" people to come forward during the slow summer months. Officials say they are doing nothing wrong; the prizes have all been donated by a local university.

CITY REPEALS BAN ON LEAFLETING Part 2

Kathy Ramsey and Al Brunn challenged the ordinance in the city of Pittsburgh that prohibited leafleting. In this two-part series, Kathy explains how the judge's decision was made and how it relates to the First Amendment of the U.S. Constitution.

In court the city claimed that the mere placing of a leaflet on a car was littering. As far as hand to hand distribution, the ordinance stated that anyone distributing leaflets by hand could be fined if it was found that his leaflets had "caused litter" and the same with anyone who wanted to place leaflets on people's doors or stoops. Anyone who has leafleted hand to hand or by placing them on cars, etc., will tell you that he will find some of his leaflets on the ground because (barring the wind) people had taken them and thrown them on the ground. To clarify, authorities can cite a person as he is leafleting or trace a leaflet back to a person or organization and cite them. We asked what happened to the existing laws against littering. Even Judge Cercone asked this. The city answered that there was not enough manpower to fine everyone who was littering. Fortunately, you can't use the

excuse of a shortage of manpower to take away our constitutional rights.

In 1939 in Schneider v. New Jersey, the Supreme Court said, "We are of the opinion that the purpose to keep the streets clean and of good appearance is insufficient to justify an ordinance which prohibits a person rightfully on a public street from handing literature to one willing to receive it. Any burden imposed upon the city authorities in cleaning and caring for the streets as an indirect consequence of such distribution results from the constitutional protection of the freedom of speech and press."

PA SENATE BILL 750 IS BAD NEWS

Letters, emails and phone calls should go to members of the PA Senate, urging them to dump the Revised Anatomical Gift Act, a bill that poses threats to PA citizens.

- 1) **Senate Bill 750** creates presumed intent for organ donation. Your 'NO" is not considered a refusal and does not get recorded.
- 2) **Senate Bill 750** creates presumed consent when it is stated, "The hospital may not withdraw or withhold any measures which are necessary to maintain the medical suitability of the part." These "measures" are not defined and may be harmful to the "organ donor" for the benefit of the "part" for the recipient.
- 3) **SB 750** removes "sound mind" requirement to consent to being a donor. Elderly and mentally ill will be taken advantage of by tissue banks and others who offer "free cremation" in exchange for whole body donation.
- 4) **SB 750** lacks requirement for fully informed consent that explain the procedures of preharvesting treatments to "ensure the suitability of the part" and how the patient is either kept on a ventilator, reventilated and/or placed on a heartlung machine to facilitate organ harvesting.
- 5) **SB750** lets **technicians** "remove/process parts from a living donor declared "brain dead" but has respiration and circulation.
- 6) **SB750** states: "During a terminal illness or while injured, "by any communication" can mean that the donor made an anatomical gift."
- 7) **SB750** states: "**Revocation**, suspension, expiration or cancellation of a driver's license or I.D. card upon which an anatomical gift is indicated **does not invalidate the gift.**
- 8) **SP750** allows an expanded list of more "persons," to donate more of a donor's "parts."
- 9) PA SB 750 allows children age 16 in PA to consent to organ donation.
- 10) **PA SB 750 Removes personhood** from the living individual. as he is then labeled "donor."

Be vigilant. Don't let your rights be taken away.
