Brigham's mill is at 320 Fort Duquesne Blvd., in the center of Pittsburgh's downtown "Golden Triangle."

According to Brigham's web site, he operates 15 abortion mills in four states, even though he no longer has a medical license in any state. The New Jersey Board of Medical Examiners suspended his license in 2010 because of his scheme of beginning abortions in NJ, where later term abortion is not legal and then transporting the women to Maryland to dismember and remove the dead babies.

Abortion practitioners Brigham has employed include an admitted sex offender, two convicted drug violators, a convicted income tax cheat, an abortion practitioner convicted of billing fraud, and several abortion practitioners who are unable to obtain hospital privileges. One man is 88 years old and has had a stroke rendering one arm useless. He is listed as the "physician of record" for an abortion in early August 2010 of a woman who was 33 weeks pregnant.

Local state officials should know about what happens in Brigham's offices. If we do not tell them, who will? If we do not persuade them to do the right thing to put him out of business, who will?

LOCAL REP = CATHOLICS FOR CHOICE



The April 5, 2011, issue of **Politico** has "An Open Letter from the Catholic State Legislators to Our Colleagues in the US Congress." The letter tells Congress that they are "deeply troubled by current legislative efforts to defund Title X." They never mention how much Title X money

goes to Planned Parenthood or the fact that PP receives billions from taxpayers. They don't mention that PP is the largest abortion provider in the country and the world. They do not describe their organization, **Catholics for Choice** as a pro-abortion, very un-Catholic partner in doing PP's dirty work. We wonder why local state representative **Chelsa Wagner** signed this letter. We hope her constituents will call her office 412-343-2094 or 412-881-1005 and ask her.

Catholics for Choice has twice been condemned by the bishops' conference as a fraud. The group has never raised as much as a dime from practicing Catholics. When CFC held a workshop at PP in Collier County, FL, the Diocese of Venice called the event "an attempt to distort Catholic teaching to advance... (an) agenda that is offensive to Catholics." The message of CFC: "You can be prochoice and Catholic—carries as much credibility as saying you can be pro-genocide and Catholic."

"THE SHOT"



Depo-Provera is a long-acting progestin hormone. It is injected into a woman's muscle every three months. It works by decreasing ovulation, by inhibiting sperm transport and by

changing the lining of a woman's uterus.

Ethical concerns: By changing the lining of the uterus, Depo-Provera can cause an early abortion when conception does occur. **Medical side effects:** The results of two major world studies have shown that women who take Depo-Provera for two years or more before age 25 have at least a 190% increased risk of developing breast cancer.

- -Depo-Provera may reduce a woman's bone density. It may worsen her cholesterol level.
- -May suffer a 430% increased risk of developing cervical cancer if receiving injections for five years.
- -Can have a much **higher rate of contracting the AIDS virus** if their partner is infected, with one study showing a 240% increased risk. *Source: What a Woman Should Know About Birth Control* <u>www.onemoresoul.com</u> 2011.




This beautiful lady and her message are saving lives all over the

CITY REPEALS BAN ON LEAFLETTING

As of August 15, 2011, Ordinance 601.02 of the City of Pittsburgh has been repealed and any person(s) wanting to leaflet cars or distribute leaflets within the city may do so without the fear of being fined for leafleting or littering. I want to thank Al and Sally Brunn who first contacted the American Center for Law and Justice and asked me to do the same. We want to thank the ACLJ and their attorney Ed White who did an excellent job of proving that this ordinance was unconstitutional as it went against both the First and Fourteenth Amendments and should be repealed.

The Judge for the U.S. District Court of Western PA, Judge Cercone, never ruled on our case, but he did agree that the ordinance infringed upon free speech. He ordered that we come to an agreement with the City of Pittsburgh. That agreement was that the city would repeal the ordinance in its entirety and pay our lawyers \$35,000, which it did.

ABORTION STATS FOR MAGEE-UPMC

Often when we publish abortion statistics from the PA Department of Health, people are surprised and disappointed to learn that Magee-Womens Hospital of UPMC is one of the culprits. It is unfortunate that current events will make it more difficult for women to have a real choice as to where they receive obstetric/gynecological care.

WORLD REACHES 7 BILLION

A press release by the United Nations Population Fund (UNFPA) states that the world's population will reach 7 billion people on October 21, 2011.

According to Population Research Institute President Stephen Mosher, the release implies a desire for more population control. Mosher will what he can to stop it.

Mosher's words come to fruition when we hear that UNFPA's Executive Director Dr. Babatunde Osotimehin reveals that "a world of 7 billion is both a challenge and an opportunity. Globally, people are living longer, healthier lives and choosing to have smaller families." But Osotimehin adds that "the population projections underscore the urgent need to provide "safe and effective" family planning to the 215 million women who lack it.

Notice that she does not say that they want it or need it. No doubt Planned Parenthood has their ears to the ground, already listening to the cash registers ringing with profits even beyond the billions they now collect. [Ed.]

BOOK REVIEW

Power Over Pain: How to Get the Pain Control You Need

by Eric M. Chevlen, M.D. and Wesley J. Smith

Steubenville, Ohio: International Task Force, 2002; 236 pages Reviewed by David E. Capan

Many readers of this newsletter are probably familiar with the name of Wesley J. Smith, a prominent pro-life lawyer. But this is probably not the case with Dr. Eric Chevlen, who is nonetheless an internationally-known expert on pain control, and who apparently still practices in Youngstown, Ohio.

One reason for reading this book is that it can serve as a useful tool to assist those in chronic and/or severe pain in their potential vulnerability to the siren song of the "death with dignity" crowd to "mercifully end their needless suffering", as they like to put it.

Since religion is important to many readers of this newsletter, be aware that this book approaches the subject of pain control strictly from a medical standpoint. Supernatural aspects such as miracles or redemptive suffering are beyond its scope. However, this in no way detracts from its usefulness on the natural level. Dr. Chevlen, who is Jewish, does have an interest in religious questions, as evidenced by his occasional contributions to the ecumenical journal *First Things*.

Although the book indicates joint authorship, clearly most of it is Dr. Chevlen's. Of the numerous vignettes sprinkled throughout the book, I believe all but one or two are his. Presumably Mr. Smith contributed the chapters on hospice and health insurance.

Readers of this book will learn many things, some of which run counter to common belief. Perhaps the most prominent example is the repeated insistence that opioids in general, and morphine in particular, are not addictive at any dosage as long as they are used to properly treat pain. Dr. Chevlen devotes a whole chapter to morphine, evidently because so much about it is misunderstood. distinguishes between addiction and dependence, discusses side effects of various drugs, and takes these and other factors into account in calibrating which drugs and what doses are optimal in any given case. He recognizes that every patient is unique, that what he does is as much an art as a science, and that persistence and flexibility are crucial when treatments at first do not work. The overarching theme, suggested by the title, is one of hope – most pain victims, properly treated, need not live in agony.

For those in need of chronic pain relief, or who just want to know more about it on a lay level, this book would seem to be just what the doctor ordered.

LETTER FROM THE PRESIDENT WHILE...



If you read any magazines or even the newspaper, you are constantly reminded of the multitude of wonderful things you can accomplish WHILE you do something else. Cut coupons WHILE you watch television; listen to the newest best seller WHILE driving

to your vacation. Do a load of laundry WHILE you clean the bathroom. Make dinner in the slow cooker WHILE you do the shopping.

During the summer after seventh grade, I read *The Diary of Anne Frank* WHILE I babysat the kids across the street. Books can change us. I kept thinking, "What were the people of Holland doing WHILE this ordinary Jewish family were being taken to the concentration camps? All but Mr. Frank would be killed, including Anne.

And the answer came in an article on the new best seller, *In the Garden of the Beast*. WHILE the Holocaust raged in Europe, most people just went around trying to get through a difficult time; they worked at their jobs, fed their kids, celebrated the holidays, read, slept, worried—things WE do every day WHILE the horror of abortion kills one out of every three American children.

And you know the question will be asked. When all the blinders come off and the truth is finally stated loud and clear, our generation is going to hear, "Gram, we read about *Roe v Wade* in class today. What were you doing WHILE all those babies were aborted and died?"

Here's what we can do WHILE others choose to ignore what's happening WHILE we pass through this age.
