ABORTION: A WOMAN'S RIGHT TO KNOW DVD 26 minutes – Pearson Institute, Inc.

In 27 minutes the DVD lists problems during or after abortion with statistics, problems that occur later after abortion. We see graphic pictures of first and second trimester abortions and hear explanations of how they are performed.

The narrator explains RU-486 abortion and how scar tissue can cause future miscarriages and/or tubal pregnancy.

We see an interview of a woman who had to have a breast and ovary removed because of cancer after abortion. We also hear from several people who are very knowledgeable concerning breast cancer's link to abortion. There is a brief Q&A segment. The Pearson Institute covers a lot that young people need to know but are not being told.

BANGLADESH STUDY: 20-FOLD BC RISK



The Coalition on Abortion/Breast Cancer reported in August on a Bangladesh study published in the Journal of Dhaka Medical College. The authors found a statistically significant 20.62-fold increased risk among women

with abortion histories – by far the highest risk elevation reported among 73 published abortionbreast cancer studies. Professor Joel Brind (City U. of NY) explained: "Almost all the women are married (97% currently married; the rest widowed) and with child by the time they are 20, and all of the children are breastfed. Ninety percent had their first child at age 21 or younger (99% of controls did). They typically take no contraceptive steroids nor have any abortions. Nulliparity (childlessness) or abortion before first term pregnancy (both of which mean no breastfeeding) in a population where breast cancer is almost unheard of, makes the risk very high. *To read the entire article and further information, go to www.abortionbreastcancer.com.*

PRAY FOR PITTSBURGH ABORTIONISTS

SWISS RIGHT-TO-DIE LAW

Ooops! Problems with diagnoses have been evident in the Swiss assisted-suicide trade lately. One case was especially tragic. It involved Pietro D'Amico, a 62 year old magistrate from Italy, who, after receiving a terminal diagnosis, traveled to Switzerland to end his life before his condition progressed. But when an autopsy was performed, they found that the father-of-one had been given the wrong diagnosis by his Italian doctor and a Swiss doctor. In fact, he was not suffering from any lifethreatening condition at the time of his death.

ABORTED BABIES' TISSUE = PROFIT



Pro-life legal group, Alliance Defending Freedom is working to stop the use of tissue from aborted babies from being illegally used in cosmetics

in Hungary. ADF Senior Legal Counsel Daniel Lipsic will participate in a hearing in Hungarian General Court in a criminal case involving harvesting of embryonic stem cells and tissue from aborted babies and using them for profit in cosmetic procedures.

In 2009, nine people were arrested for using cells and tissues from aborted babies for commercial gain. At a Kaposvár, hundreds of patients agreed to be injected with cells and tissues for \$25,000 per treatment.

We will follow this case with ADF.


