40 DAYS OF PRAYER AND PRESENCE





JASON JONES = BANQUET SPEAKER IN SEPTEMBER

Jason Scott Jones is a filmmaker and human rights activist. He works directly to aid the homeless,

peoples facing genocide, and women with crisis pregnancies.



Jones began working in defence of life while attending

the University of Hawaii. He founded the Pro-Life Student Union and served as State Chairman of Young Americans for Freedom (YAF). Jones would go on to serve as director of Hawaii Right to Life, youth director of American Life League, grassroots director of Brownback for President, and public relations director for the Human Life International. He has appeared on ABC, Fox, CNN, and hundreds of radio programs.

Jones is the Founder of HERO [Human-Rights Education and Relief Organization] a non-profit that promotes human dignity regardless of ability, age, status, race, or geography. He led a HERO initiative to bring clean water to refugees in South Sudan. In 2009, despite warnings of unsafe travel, Jason visited Darfur. He distributed \$2 million in aid.

Jason's Movie to Movement will transform the culture by promoting films with a message of beauty, truth, and love.

Jones is co-executive producer of **BELLA**, winner of The People's Choice Award at the 2006 Toronto Film Festival. **BELLA** inspires women in crisis pregnancies to choose life.

Jones' film, **Crescendo** raised more than \$5 million in support of women in need.

His first book, The Race to Save Our Century: Five Core Principles to Promote Peace, Freedom, and a Culture of Life, appeared in September 2014. YOUNG ABORTION PATIENTS RECRUITED





N.B. As you read this article, please measure the worth of the "subjects" used. Note that the babies being killed are deemed of **no** value. Surely these scientists could find a better way to do this research. [ED.]

The University of Hawaii is recruiting patients as young as 14 for second-trimester abortions to determine how much they bleed during the procedure. The controversial study is underway at the Kapiolani Medical Center in Honolulu, led by Bliss Kaneshiro, MD and Kate Whitehouse, DO.

In the randomized trial, researchers experiment by either providing or denying intravenous oxytocin to abortion patients. Oxytocin minimizes blood loss and decreases risk of hemorrhage. Some doctors are concerned that denying oxytocin during surgery may put patients, especially teen girls, at risk.

Abortion patients must be from 18-24 weeks gestation and from 14-50 years old. Dilation and evacuation abortions are grisly 2-3 day procedures that involve dismembering the pre-born baby in order to remove him or her from the womb.

Applicants who work in the area of the experiments must be comfortable watching dismemberment abortions. The study is being done by the University of Hawaii in collaboration with Society of Family Planning and the University of Washington. (Operation Rescue Frontlines 3-31)

TRIB INVESTIGATES ORGAN HARVESTING



Harvesting human body parts is a multimillion-dollar industry, according to an investigative report in the August 31, 2013, Pittsburgh *Tribune-Review*. Based on 2011 federal filings and tax documents

of the nation's 51 independent organ procurement organizations (OPOs), the *Tribune* reported:

- * The "nonprofit" OPOs post hefty surpluses each year. LifeNet Health of Virginia Beach led the OPOs with a reserve of over \$95 million.
- * Six-figure salaries: top executives averaged \$320,000 in total compensation in 2011.
- * Nepotism and board members paying themselves: Tampa-based Lifeline Foundation paid its top two executives a combined \$1.1 million and four relatives \$600,000 more.



"CRUEL INDIFFERENCE TO WOMEN"



As if on cue, Planned Parenthood is accusing the University of Scranton of cruelty since it announced that, in line with the Jesuit University's Catholic identity, faculty and staff health care

would no longer include coverage for abortion in cases of rape, incest and for the mother's life. The eastern PA university said employees of the University have a responsibility to "behave consistently with the Church's moral teaching on abortion," said President Kevin Quinn, S.J., in his letter to faculty and staff.

Fr. Quinn, in a second statement, assured that University insurance "would continue to cover medical procedures that are intended to preserve the life of the mother so long as these procedures are not a direct abortion."

TERRY SCHIAVO & PETER SINGER

It is the tenth anniversary of the death of Terri Schiavo on March 31, 2005 – probably the most controversial bioethics case of all time, if measured by column inches in newspapers or the tonnage of

court documents. And it is the 40th anniversary of the publication of *Animal Ethics*, the book which launched Peter Singer's career as a public philosopher.



The two events have much in common. Terri's life support was withdrawn because American courts were persuaded that because she no longer had interests which extended over time, she would suffer no harm in

dying. And Singer's main argument for expanding the circle of protection to include pigs and dolphins is that they do have these interests.

From this angle the most important issue in bioethics must be: is there anything special in simply being a human being, regardless of how conscious he or she is, regardless of whether his or her interests extend over time? At the moment the pendulum seems to swing towards Singer's utilitarianism. I wonder whether there will be a reaction as he fades from the scene.

LETTER FROM THE PRESIDENT

Dear Friends for Life,

During the mid-1960s three major events took place: First, the 1963 Supreme Court Ruling on *Murray O'Hair v Curlett* ended prayer in public schools. Second, the sexual revolution was in high gear, thanks in part to Alfred Kinsey's so-called "scientific" studies of sex and sexuality in America. Last but not least: acceptance and distribution of the birth control pill.

All of this set the stage to remove the cultural stigma on abortion. Usher in NARAL, co-founded by Dr. Bernard Nathanson. In his book, *Aborting America*, Nathanson revealed that he and fellow abortion crusaders pursued dishonest strategies to eliminate legal restraints on abortion. First, "abortion is a medical issue, not a moral one. The Hippocratic Oath's prohibition of abortion had to be removed." In the end *Roe v Wade* was passed in 1973. Second, they lied about the number of women who died each year from back alley abortions. They invented statistics to back up their argument. Third, NARAL and other abortion leaders needed an "enemy." They decided to "sell the Catholic Church as the freedom-smothering oppressor."

After his pro-life conversion, Nathanson wrote his autobiography, *The Hand of God*, in which he confesses his own "heartlessness in performing abortions." Nathanson was baptized into the Catholic Church in 1996 by Cardinal O'Connor of New York.

So, where are we today? The slippery slope we watched years ago is "rolling downhill like a snowball headed for hell." The same lies, the same misdirected emotions, the same greed, the same propaganda are thrust upon us to legalize euthanasia.

With a pro-death culture, a pro-death Administration and an apathetic public, the pro-life community must be *aware* and *willing* to fight the onslaught of so-called "death with dignity legislation.

In Oregon euthanasia has been law for several years under strict guidelines. The spiders began to gather in their prey under House Bill 3337, co-authored by Barbara Combs Lee. This bill would stretch the meaning of terminal illness from six months to 12 months. John Kelly, writing for **Oregon Live**, reports there is a broader agenda to target dementia patients, people with significant disabilities and mercy killing of disabled newborns. Shades of the Hitler administration.

Washington and Vermont more recently passed "death with dignity" legislation, a euphemism for "blood bath."

Where is Pennsylvania in all of this? On April 10, 2015, three democrats and two republicans introduced <u>House Bill 943</u> providing for procedures regarding the request and dispensation of lethal medication to patients seeking to die in a dignified and humane manner.

The marriage of Euthanasia to Medicare is only a skip away. As reported by the *Robert Powell Center for Medical Ethics*, the Obama Health Care Law will cut \$555 billion from Medicare over the next ten years. The government program that provides health insurance to older people faces grave fiscal problems as the baby boom generation ages. Medicare is financed by payroll taxes, which means those currently working are paying for the health care of those now retired. As the baby boomers move from middle into old age, the proportion of the population that is retired will increase while the proportion of the population that is working will decrease because of abortion and birth control.

The pro-life movement must act on this hideous legislation. There is no time to waste.

KILLER GETS AWARD & PROMOTION

Lakisha Wilson, mother of a young son, was tragically killed during a botched second trimester abortion done by Lisa Perriera in Cleveland, OH, last year. Now, Physicians for Reproductive Choice will



give her the George Tiller, MD, Abortion Provider Award for 2015, which "recognizes a physician early in their career who provides abortions while demonstrating leadership and courage, even in the face of adversity."

That "adversity" meant many calls for disciplinary action and criminal charges related to Wilson's death by pro-life groups.



Astonishingly, in addition to this award, Perriera was promoted to a position as the Ryan Residency Training Program Director at Thomas Jefferson U. School of Medicine in Philadelphia, PA.

"Somehow, it seems almost appropriate for Pirierra to flee her embattled position in Cleveland for refuge in the hometown of Kermit Gosnell. They actually have a lot in common having both killed patients during abortions," said Troy Newman, president of Operation Rescue.

SUICIDE BILLS IN PA SENATE AND HOUSE



Two very similar "DEATH WITH DIGNITY" bills were presented to the PA House and Senate. SB549, introduced by Sen. Daylin Leach with one co-sponsor, and HB 2548, sponsored by Rep. Mark Rozzi and two other representatives, each use 19 pages to "push Granny off the cliff."

We urge pro-lifers to email or call their local Senator and Member of the House and urge them to reject these bills. We watched recently as a young newlywed who received a diagnosis of brain cancer fell into the clutches of the "right to die" promoters—all of whom

are very alive. The media made her a celebrity up to the day she died.

Meanwhile, another beautiful young woman, also with an inoperable brain tumor, fought up to the end, even scoring the first and last basket for Mt. St. Joseph on November 2. Did you hear all about her from the national media? I don't think so.

Jones began working in the pro-life movement while attending the University of Hawaii. There he formed the Pro-Life Student Union and also served as State Chairman of Young Americans for Freedom. He later became Chairman of the Hawaii Young Republicans and worked as Chief-of-Staff for State Rep. Mark Moses. Jones' other pro-life credentials include: Director of Hawaii Right to Life, National Youth Director of American Life League, and Public Relations Director for the world's largest international pro-life organization, Human Life International [2001-7]. As a public speaker, he travels frequently, speaking out against abortion and touching on "Responsibility" in a sovereign nation. Jones is the host of The Great Campaign on Radio Maria. He has verbally sparred with pro-choice activists on ABC's Politically Incorrect, Fox and CNN. Jones also has been a guest on EWTN.

Jones was a producer on the 2006 film, *Bella*. The film won several film industry awards, most notably it won the **People's Choice Award at the 2006 Toronto International Film Festival**.
