NO TAXES FOR ABORTION – HR 7



President Trump will sign the *No Taxpayer Funding for Abortion Act*, which passed the House, if the bill makes it to his desk. Let us work to that end!

The No Taxpayer Funding for Abortion Act makes the Hyde Amendment - which prohibits federal funding of abortions - permanent, rather than subject to annual renewal. It would also block *Obamacare* from funding abortions, often clandestinely, while Congress works to repeal and replace the law.

Making “Hyde” permanent has been a goal of pro-life lawmakers and citizens for several years, but the effort was resisted by the past President and by some Senators.

The vote on the measure was 238 to 183. Thank **Congressmen Mike Kelly, Tim Murphy, Keith Rothfus, and Bud Shuster. And ask Congressman Mike Doyle why he votes pro-abortion.** HR7 would stop taxpayer dollars from being used to pay for abortions in *Obamacare*, starting the next plan year, regardless of what happens in the struggle to repeal *Obamacare*.

NORMA McCORVEY – R.I.P.



From plaintiff in *Roe v. Wade*, to advocate for the preborn child, Norma McCorvey said she was manipulated by the pro-abortion feminists in their drive to take abortion to the Supreme Court. 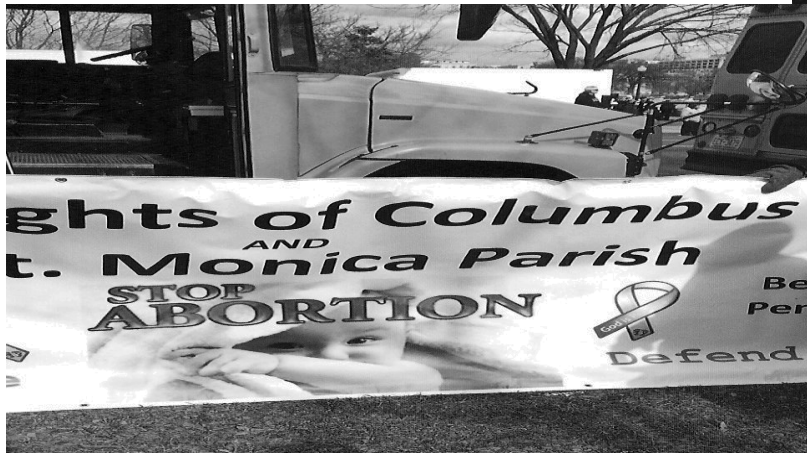
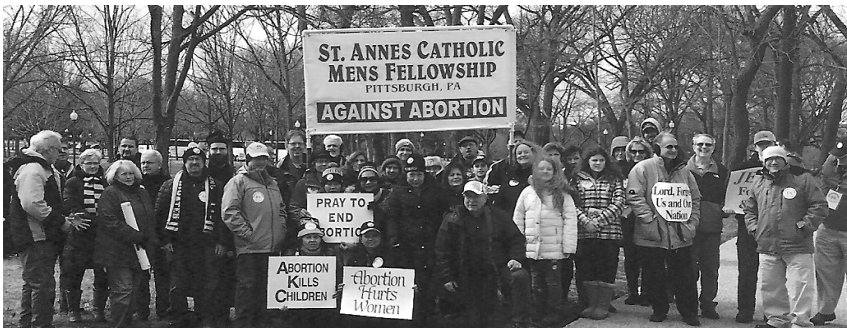

MEXICO CITY POLICY – GOOD NEWS

In one of his first acts in office, President Trump issued an executive order reinstating and even beefing up a Reagan-era executive order known as our Mexico City Policy.

Under this 1980s-initiated reform – reversed by President Clinton, reinstated by President Bush, and reversed again by President Obama – US taxpayers will no longer be complicit in the commission or promotion of abortion overseas.

The Trump order disqualifies from US funding any outfit which commits abortion overseas or advocates for abortion legalization policies in countries which outlaw the crime. This means immediate disqualification of International Planned Parenthood – and many less well-known outfits – from US funding, without needing to await Congressional action. (Enactment of a law, however, would be more permanent and could not be reversed at the whim of the next President.)

We are delighted to note that the Trump “Mexico City” rewrite appears to be even stronger than the Reagan version. It is absolutely more comprehensive than its predecessors. The Trump order now applies to global health assistance furnished by all departments or agencies, i.e., not just US Agency for International Development family planning programs; it now covers ‘involuntary sterilizations’ in addition to abortion.

These various abortion-friendly international family planning’ agencies across the world collectively received nearly \$90 million from 2013-2015 in global health assistance funding from the US government. No more, thank God!

Plus, the order appears to bar further US funding of the notorious UNFPA (United Nations Population Fund), frequently in the past a major target of pro-life Members of Congress. UNFPA has been deeply involved in promotion of abortion and has been found complicit with the Red Chinese depopulation policy, an objection which did not in the least faze the Obama Regime.

Today, we celebrate a significant step in the battle to make the womb a safe place again, noting, it is significant that Pres. Trump did this on his first full day in the Oval Office and one day after the Roe v. Wade decision anniversary. We cannot reverse the deaths of more than 58 million children, but we can reverse the tragic flow of money that allows Planned Parenthood to end the lives of innocent children.

PA HOUSE & SENATE MOVE TO PROTECT HUMAN LIFE



Legislation to ban the brutal practice of dismemberment abortions in PA passed in the Senate by a vote of 32-18. We urge you to call the Senators from SW PA who voted YES: Camera Bartolotta, James Brewster, Michelle Brooks, Scott Hutchinson, Guy Reschenthaler, Pat Stefano, Elder Vogel, Randy Vulakovich, Kim Ward and Don White. Call Senator Jay Costa and Wayne Fontana, who voted PRO-ABORTION and ask them WHY?!

If enacted in PA, this would make PA the latest state to ban abortions at 20 weeks and restrict how the vast majority of second trimester abortions are performed. The bill passed after an emotionally charged debate.

In the House, HB 77 was introduced by Rep. Kathy Rapp. In 2016 Rep. Rapp authored HR1948. It passed in a bipartisan 132-65 vote. We truly appreciate the leadership of our legislators.

Call these U.S. Congressmen right away! Thank them for their pro-life votes on HR Res 43, overturning Obama regulations forcing states to include Planned Parenthood in the grants and contracts issued under Title X (ten) Family Planning programs. The Resolution passed in the House of Representatives by votes of 230-188.

Then call MIKE DOYLE 412-241-6055. Ask why he votes pro-abortion instead of sticking to the PRO-LIFE principles that got him elected in the first place. In what other area in our culture does a change in the geography of an occupation mean a person must change his position on the life and death of fellow human beings?

HISTORY: *President Richard Nixon signed Title X into existence on December 26, 1970. How odd, that those who screamed, “Nobody has the right to know what goes on in my bedroom!!” and “Keep your rosaries off my ovaries!” demanded that U.S. taxpayers PAY for all the activities we were not allowed to talk about???*

Title X is a federal grant program that provides funds for “family planning” services. Of course, we all know that “family planning” usually means having taxpayers pay for NOT having a family because the drugs and plugs we pay for are designed to prevent or destroy any human reproduction that might take place.

Many states have passed laws to exclude Title X funds from PP. Some Title X funds go to private entities, but many states are the main grant recipients. These states realize that money is fungible. When Planned Parenthood or other abortion providers receive “family planning” funding, it frees \$\$\$\$ so they can spend more on abortion.

Keep in mind that very little—almost NONE of the money YOUR TAXES give to PP is used for prenatal care or adoption. NONE of YOUR money goes for breast cancer screening. In fact, if you go to PP for a mammogram, they take a cut and give you a referral to a facility that has the equipment for mammograms.

Don’t be fooled. Abortion is PP’s main occupation. Ask those who wised up and quit.

REPEAL OBAMACARE – RES 3

SB 361 – ANOTHER BAD BILL



PA Senate Bill 361, sponsored by pro-abortion PA Sen. Anthony Williams (D-Delaware & Phila. Counties) would take away the people’s right to vote for appellate judges and, instead, give the power to pro-abortion Gov. Tom Wolf to appoint justices to the PA Supreme Court and judges to the PA Superior Court and Commonwealth Court. The Governor would nominate judges based on a list of names supplied by a small elite group unaccountable to voters.

The process would not eliminate politics from the system of electing judges—it would just put politics behind closed doors, away from public scrutiny. THIS IS A VERY BAD PROPOSAL!!

JOHNSON AMENDMENT



What is the Johnson Amendment? In 1954, then Sen. Lyndon Johnson found a way to punish a non-religious, nonprofit for daring to support his rival. With the Trump-proposed repeal, all 501(c)(3) nonprofit organizations would regain the freedom to act in ways that have not been allowed since 1954.

Provisions are in the U.S. Tax Code that prohibit all 501(c)(3) nonprofit organizations from endorsing or opposing political candidates.

Why shouldn’t religious groups have the same political rights as others? The repeal would allow all nonprofits to speak freely on political candidates. One’s religious faith often shapes one’s politics. President Trump has promised to “blow up” the wall of separation between church and state, but he can’t change the tax code because he also needs the support of Congress.

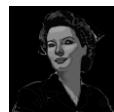
FRENCH TRY TO IGNORE REALITY



With their talent for tact, the French try to dampen the controversy over abortion by disguising it with an acronym, IVG, *Interruption Volontaire de Grossesse*, voluntary interruption of pregnancy. It takes the sting out of raw reality.

The French government has taken this eye-averting circumlocution further by banning pro-life websites. It is now a crime punishable by two years in the slammer "to spread misleading information about abortion." Translated, this means offering a different point of view on the internet.

POLICIES AGAINST CPR PROHIBITED



The Centers for Medicare and Medicaid Services (CMS) issued a memo emphatically prohibiting the establishment and implementation of policies that do not allow nursing home staff to administer cardiopulmonary resuscitation (CPR) to patients experiencing cardiac arrest.

In CA a nurse called 911 to report a woman in a senior living facility who was having respiratory distress. When the dispatcher told the nurse to administer CPR until medics arrived, the nurse refused, saying the facility's policies prohibited it. The woman died.

CMS acknowledged that sometimes CPR is not effective, but that was NO EXCUSE to sit back and do nothing. *Patients Rights Council Vol. 28*

PA SB 238 = DEATH IS NOT PROUD



On January 26, 2017, pro-death PA Sen. Daylin Leach again introduced his so-called “Death with Dignity” bill, SB 238. At that time, the only co-sponsor was Sen. Lisa

Boscola. “An Act amending PA Title 20 of the PA Consolidated Statutes, providing for procedures regarding the request and dispensation of lethal medication to patients seeking to die in a dignified and humane manner, for duties of attending physicians, for duties of consulting physicians and for insurance or annuity policies; imposing duties on the Department of Health; providing for immunities and for attorney fees; and imposing penalties.”

The bill goes on for 17 pages, all of which are designed to protect those who will participate in the killing while the man or woman whose life will be ended may be hoping it will never happen.

At this time, neither the members of the PA General Assembly nor the citizens of our commonwealth want this blot on our culture, but as we have seen in other states and countries, the forces pushing this sort of evil will not go away. They will use words like “dignity” and “choice” (we’ve seen THAT term *ad nauseam*) to push their agenda. It’s up to all of us to teach our family, friends and neighbors the reality of these practices.

Now legal in five states, suicide has become a popular topic for sensational media—the kind you see on your way to the cashier at the supermarket.

Let us always look to love, comfort and compassion for the dying. St. Teresa of Calcutta showed us how to care for the poorest of the poor. Surely we can follow in her footsteps for our loved ones.

Soon the hearings will start, and every media outlet in the country will spout their interpretation of what Judge Gorsuch “really means” by the responses he gives to the Senate. We have heard some very good reports as to his views on some topics, but we have no definitive response to the question that means most to pro-lifers: **HOW WILL HE RESPOND WHEN ROE V. WADE IS CHALLENGED?**

We know he favored Hobby Lobby in their 2014 Court Case. We know he is a Constitutional Originalist, meaning he would interpret the Constitution as it was written, not as an “evolving” document. He is against the legalization of Assisted Suicide and Euthanasia. **VERY GOOD!** He says the Judiciary has become “too political.” He has said little about abortion. And that is our **BOTTOM LINE!!!**
