DEMS VOTE OKS POST-ABORTION KILL




give abortion-bound women and men real help and hope in order to help save lives is an essential part to ending abortion through God's grace.

PA SENATORS - A COMPARISON

Sen Pat Toomey has a solid pro-life voting record. He is a co-sponsor of the Pain-Capable Unborn Child Protection Act (S.160) and the No Taxpayer Funding for Abortion and Abortion Insurance Full Disclosure Act (S.109). "WE'RE NOT SORRY"



When doctors told Todd and Nicola Bailey that their twin daughter Harper had Down syndrome, they broke the news by saying, "I'm sorry." But the proud parents insist that there is nothing to be sorry for. "Our family is unique, and I wouldn't change it for the world," says Nicola.

The Sheffield, England couple, who are also the parents to four-year-old Lucas, didn't find that Harper had the genetic condition until she was born, 38 minutes before her twin sister, Quinn.

"All I remember is the doctor saying, 'I'm sorry," says Nicola of when the diagnosis was delivered. "But as soon as I saw them both, my heart just melted. They were both so beautiful."

Nicola, a nurse, is now striving to educate people about Down syndrome and reduce the stigma. "Harper is Harper, and Quinn is Quinn—they are not the same, so I try not to compare them, however hard that may be...Harper is perfect. I would not change her. Her little smile lights up the room, and she is who she is supposed to be."

KAVANAUGH SLAMMED ROE IN 2017



The text of a speech Brett Kavanaugh gave in 2017 has people on both sides of the debate wondering if it's an indication that he would be open to overturning *Roe v Wade*.

The speech was mostly about former Supreme Court Justice

William Rehnquist and assisted suicide, but when you read it you see Kavanaugh essentially in agreement with Rehnquist's assertion.

Kavanaugh's speech was based on the case of Washington v. Glucksberg, involving an asserted right to assisted suicide. Rehnquist wrote the opinion for the Court saying that the unenumerated rights and liberties protected by the due process clause are those rights that are deeply rooted in the nation's history and tradition. And he rejected the claim that assisted suicide qualified as such a fundamental right.

What makes the passage "Roe-skeptical" isn't his claim that the Court "created" the right to abortion; it's his cautiously pejorative references to that process. It wasn't just that judges created a right in Roe. It was that it was part of a "freewheeling" judicial trend at the time. It's hard to imagine a judge, particularly a conservative judge, ever using "freewheeling" as a compliment to describe a turn in jurisprudence.

Trump applauded Kavanaugh as someone who would apply the Constitution as written. Planned Parenthood launched a fierce attack on Kavanaugh, claiming he would "wreak havoc" on abortion. Source: Life News 7-12-18. Call for full article

WHAT WE ALREADY KNOW

A report that examined the encounter between students from Covington Catholic High School and a Native American activist near the Lincoln Memorial found "no evidence" of "offensive or racist statements."

"We see no evidence that students responded with any offensive or racist statements," the report dated Feb. 11 from the detective agency Greater Cincinnati Investigation read. The report was commissioned by the Catholic Diocese of Covington, Kentucky.

Nick Sandmann and other students of Covington Catholic High, who were in Washington to attend the March for Life faced harsh criticism in mainstream and social media based on a video showing a portion of their encounter January 18 with Nathan Phillips, 64, on the National Mall.

SUIT WOULD "NY-IZE" PA ABORTION LAW

On January 16, 2019, the Women's Law Project, on behalf of the abortion mills in PA that admit to committing 95% of the abortions in PA, filed a lawsuit that seeks a declaration from the PA Supreme Court that a "right to abortion" now exists in the PA Constitution. Their immediate goal is to fund all Medicaid abortions, which numbered approximately 13,000 per year prior to PA's Medicaid funding restrictions taking effect in 1985. These restrictions have resulted in a sustained decrease of approximately 5,000 abortions per year in PA.

The good news is that the pro-life majority in the PA House and Senate can pass a Constitutional Amendment, as other states have done, that establishes that the PA Constitution contains no "right to abortion.

ALSO FROM HARRISBURG

We are also pleased to hear that House Speaker Mike Turzai and Rep. Judy Ward will introduce a bill that will prohibit abortion of preborn babies diagnosed with possible Down syndrome. First introduced last year, this bill would let the world see that babies with one extra chromosome are as worthy of life as their brothers and sisters without that "extra touch." Elsewhere in this month's newsletter is the story of a family whose new-born twin daughter was born with Down syndrome while her sister was not.

PA already has a law that gives every mother who gives birth to a child with Down syndrome the immediate aid she needs for early intervention in the physical, mental and educational needs for her child. We do not want to become like other countries of the world where the "cure" for Down syndrome is to kill the child. They are precious assets in our society.

WATCH FOR ABBY IN "UNPLANNED"



Scheduled for release on March 29. Watch for "UNPLANNED" in YOUR neighborhood theater. The ratings agency gave it an "R," maybe hoping to keep us

UNITED WAY CONTRIBUTES TO PP



Despite the fact that Planned Parenthood is the nation's biggest abortion business, a report published by 2nd Vote indicates that United Way

affiliates fund it with millions in donations.

Analysis of recent IRS Form 990 filings and other documentation found 62 United Way affiliates sent \$2,756,799 to PP abortion organizations in tax year 2016, an increase of \$168,806 from donations in 2015.

According to PP, an abortion can cost up to \$950. If that is true, it means United Way dollars essentially paid for the equivalent of at least 2901 abortions over the course of a single year.

Does your local United Way donate to PP? "The Pro-Life Guide to United Way" was released on 2nd Vote's site. It has a state-by-state list of every United Way in the U.S. Each entry shows the amount of money donated to PP with a link to tax forms documenting the expenditure.

When we checked the 2nd Vote site, (it takes a little looking) we learned that most local United Way agencies do NOT donate to PP. Philadelphia and United Way of Allegheny County **do** give money to PP. In 2016 PA United Way agencies gave \$341,317 to PP.
