


Beloved since our beginning, Fr. Scott has been with PCUC throughout all of our joys and sorrows. He has been our friend and trusted advisor.

HHS TO ALLOW FAITH-BASED ADOPTION



The Department of Health and Human Services (HHS) on Nov. 1 announced a proposal that will no longer withhold federal grant money from faith-based adoption and foster agencies that refuse to place children in same-sex

households due to their belief in traditional marriage.

With an estimated 400,000 children in the U.S.' foster care system and more than 100,000 eligible for adoption, the Trump administration argues that the new rule is necessary to support the efforts of religious providers who help vulnerable communities. Enforcement will begin immediately.

30,000 DOCS SAY: "ABORTION NEVER MEDICALLY NECESSARY TO SAVE MOM'S LIFE."

In a letter published at The Public Discourse, leaders of the American College of Pediatricians, American Association of Pro-Life Obstetricians and Gynecologists and other medical groups explained their support of the Born Alive Abortion Survivors Protection Act. The Bill, which narrowly failed in the U.S. Senate in March, would require that abortionists provide the same basic medical care to an infant who survives an abortion that doctors would to any other baby born at the same gestational age. *Democrats claimed the bill was an attack on "women's health care."*

Defenders of the bill said abortions—"the guarantee of a dead baby"—are never necessary in the rare cases when a mother's life is in jeopardy late in her pregnancy."

900 ABORTION CLINICS LOSE \$\$\$\$

Power to Decide, a pro-abortion organization, says in a new report that 876 clinics across the country have lost funding since the Department of Health and Human Services (HHS) under President Trump prohibits Planned Parenthood and other abortion businesses from receiving tax dollars unless they separate their abortion businesses from their taxpayer-funded services. That means housing their family planning services in separate buildings with separate staff from abortion businesses and a denial of funds if they fail to do so.

DALEIDEN'S CMP FILES SUIT

David Daleiden's *Center for Medical Progress* has filed a defamation lawsuit against Savinda Gende, one of the then-Planned Parenthood abortionists featured in CMP's video footage documenting the abortion outfit's complicity in the baby-body-parts trafficking.

In a *Live Action News* report, Carole Novielli quotes one provision of the lawsuit: "Dr. [Savita] Ginde published a book and made a TEDx presentation in which she falsely claims that the videos were 'dubbed' and 'spliced and diced,,,' and that they did not reflect her actual statements...The Ginde Videos,'" states the suit, quoted by Ms Novielli, " accurately portray the discussions that Dr. Ginde had with Mr. Daleiden during the undercover investigations. No facts were fabricated or added to the video. Neither the context of Dr. Ginde's statements, or the accompanying audio, was manipulated. *Life Advocacy Briefing 12-9-19*

MINDZENTY REPORT REVEALS HORRORS

TWO CONSERVATIVES TO NINTH CIRCUIT

Sen. Pat Toomey voted *for* the two new seats on the infamous Ninth Circuit Court, and Sen. Bobby Casey voted *against* them. Their votes cancelled each other, but we can know without looking that the new guys are conservative. That gives us hope.

One of the attorneys confirmed is Lawrence VanDyke. He was vigorously opposed by the abortion lobby and its fellow travelers in the Senate.

As Solicitor General in Montana and Nevada, Mr. VanDyke submitted an amicus brief in support of Arizona's 20-week abortion ban. He went so far as to ask the Supreme Court to reconsider *Roe v Wade*. He challenged ObamaCare's contraception coverage and his involvement in legal filings also challenged the legality of buffer zones around the entrances to abortion mills, like the yellow halfcircle around the doors to Planned Parenthood in Pittsburgh. Final vote on nomination was 53-40.

DAVID DALEIDEN SUED FOR \$1.4 MILLION

Planned Parenthood is licking their chops after the judge ordered the jury to find David guilty in PP's case against him and his colleagues.

There will be an appeal, of course, but this is the lopsided decision handed down in the case where PP personnel were videotaped as they joked and bragged about buying and selling organs, limbs, entire babies—all while eating and drinking.


