### **PRIMARY ELECTION: TUESDAY, JUNE 2**

Every election cycle is important and the Pennsylvania Primary which has been delayed until June 2<sup>nd</sup> is no exception. In 1980 PCUC formed LIFEPAC as a 501-C4 to engage politically in ways that PCUC couldn't legally. LIFEPAC's primary mission is to identify pro-life candidates in 11 counties in SW PA. When we have donated funds beyond the expenses necessary to identify and publicize pro-life candidates, we can give directly to the campaigns of important critical races. We are pleased that we can pay for our Voter Guide to be published in this PCUC newsletter. For many years we paid to have our Voter Guide printed in the Pittsburgh Catholic. We pay to print close to 100,000 flyers which have been distributed either through Direct mail or delivered in quantities to pro-life Churches. Some individuals would even pass them out at the polls on Election Day. Times are changing! Direct mail is expensive. Many pro-life churches do not educate their congregation about candidates' positions. Now we are not even sure if they will be meeting physically as a congregation before June 2. Many voters will avoid going to the polling places and choose to vote early by mail. Please help LIFEPAC adapt its ways and become more efficient by helping pro-life candidates and saving the lives of unborn children.

## SCOTUS HEARS LITTLE SISTERS



On May 7, the Supreme Court conducted arguments via telephone conference. Justice Ruth Bader Ginsberg participated from her hospital room where she is fighting an infection caused by a gallstone.

*For six years, the Catholic nuns have been forced to fight in court to be exempted from an **Obamacare** contraception mandate that requires employers to pay for sterilizations and all FDA-approved contraception methods, including types that may end the life of a baby in its mother's womb.*

In 2017, Trump administration announced a new rule to protect religious non-profits. Several pro-abortion states, **including Pennsylvania**, sued to remove the protection.

This is the second time before the Court on this issue for the Sisters who have given their lives to care for the elderly poor. On the other side, PA Attorney General Josh Shapiro insists that "Contraception is medicine. Pure and simple."

**In Commonwealth of Pennsylvania v. Trump, state Attorney General Josh Shapiro threatened the Little Sisters' ministry by challenging their religious exemption and forcing them to continue to defend themselves in court. After a loss in the Third Circuit Court of Appeals, the sisters are asking the U.S. Supreme Court to end their legal battle and let them focus on serving the elderly poor.**

**The Supreme Court decision will be announced later in the year.**

## SHAPIRO RUNNING FOR RE-ELECTION

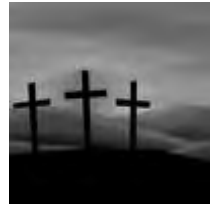

## GET *LOVING WILL* FROM ALL

We know that a "living will" provides instructions regarding your medical treatment and care when you are unable to communicate your informed consent because of illness or injury. You sign it in the presence of two witnesses and you acknowledge it in the presence of a notary public.

With a "Loving Will" you provide a number of basic, but not detailed guidelines for those who will be making medical decisions for you. You ask for necessary medical treatment and care. You ask for oxygen, food and water. You ask for maximum efforts to relieve pain (even if shortening your life is an unintended side effect). If pregnant, you ask that the maximum effort be made to save your child's life. You forbid medical decisions based on the intent to cause your death. Any ambiguity is to be resolved in favor of continuing your life.

### IDAHO ENACTS 'TRIGGER'



In late March Gov. Brad Little of Idaho signed "trigger" legislation which would outlaw abortion upon a U.S. Supreme Court reversal of *Roe v. Wade* without having to adopt new legislation in the anticipated post-*Roe* era.

Sponsor Sen. Todd Lakey (*photo*) said, "Some of you may ask why now. We don't know when the Supreme Court will change...But it may happen...when we are not in session...If this bill can save the life of one unborn child, then it is worth it. The pill reversal method is available to mothers who begin the abortion pill regimen and regret their decision. Chemical abortion is a two-step procedure. With intervention, the procedure may be reversed and the baby's life saved.

390,908-- Deaths by HIV-AIDS  
581,599-- Deaths by Alcohol  
1,162,481- Deaths by Smoking  
1,909,804-Deaths by Cancer  
2,382,324-Deaths by Hunger  
9,913,702-Deaths by Abortion
