PP's NEW REPORT REVEALS MORE THAN 8.6 MILLION ABORTIONS

Planned Parenthood released its annual report for 2019-2020 in mid-February. The document highlighted hurdles PP has faced, from the covid-19 pandemic to the Trump administration. Yet, business is BOOMING! PP counted **354,871** abortions for 2018-2019 in this report—the highest number ever recorded—according to data tracked by pro-life groups.

BABY MOLLY MAKES HISTORY



An East Tennessee baby whose birth made history by being the longest frozen embryo to ever come to birth. Molly Everette Gibson, the daughter of Tina and Ben Gibson, spent more than 27 years as an embryo, according to the staff at the U. of Tennessee Preston Medical Library.

*Molly was frozen on October 14, 1992. She was thawed on February 10, 2020 and transferred to Tina's uterus on February 12, 2020 by NEDC President and Medical Director, Dr. Jeffrey Keenan. She was born October 26, 2020, weighing 6 lbs. 13 oz. and measuring 19" long.

What makes all of this more special is that Molly broke her sister's record. Emma Wren Gibson was born in 2017. She had been frozen for more than 24 years, holding the known record for longest-frozen until her sister's arrival. The girls are full genetic siblings.

AND HERE'S THE REALLY SPECIAL PART OF THIS STORY: Dr. Keenan does this work because he believes no embryo should ever be discarded, certainly not because it is "old."

Dr. Keenan gives full credit to the excellent work by NEDC Lab Director & Embryologist Carol Sommerfelt. "She is perhaps the preeminent embryologist in the country...and of course it is a testament to how good God is, and to His infinite goodness and love."

DEATH WITH DIGNITY – ADOLPH HITLER'S LEGACY?

We're looking at an article written in 1977, but its message is just as threatening today – if not more...

In 1977, California's "Natural Death Act" became law, the first of the so-called "Death with Dignity" bills to be enacted. The California law can be likened to the edge of a wedge which opens the crack wider to active euthanasia in CA but weakens the defenses against euthanasia in other states.

In 1976, 21 death with dignity bills were pending before state legislatures. In 1977 no fewer than 36 state legislatures have been presented with bills. So far, 10 such bills have been defeated, but one passed in New Mexico.

The Euthanasia Society of America was founded 38 years ago. It won some early encouragement, but it soon ran out of steam. Probably what stopped it dead was the news that euthanasia had been a principal pastime of Adolph Hitler and had led via a broad and smooth highway to the mass murders for which he became more celebrated but hardly less infamous.

We'll do some more research on where "death with dignity" hangs out today—and who promotes it.

PRIESTS FOR LIFE AT UNITED NATIONS

The PFL International outreach team will be actively involved, as it is every year, in the United Nations 65th Session of the Commission on the Status of Women, March 15 thru 26. This year's session will again be virtual and the theme is "Women in Public Life – Equal Participation in Decision Making." Priests for Life submitted a new statement urging action to "end prenatal sex selection abortion recognized in the Beijing Platform for Action as an unethical act of violence against women and girls that begins the cycle of violence that impacts women and girls throughout their lives." PRO-LIFER TOLD TO PAY PP \$13 MILLION

Sandra Merritt, who worked with David Dalieden, the founder of The Center for Medical Progress, was ordered to pay PP over \$13 million.

Merritt and Daleiden released 14 videos in 2015 exposing PP's illegal sales of aborted baby parts after a 30 month undercover operation. The videos showed top-level PP executives haggling over prices of aborted baby parts and discussing alternative methods for doctors to better harvest fetal organs during abortion procedures.

According to Liberty Counsel, the law firm representing Merritt, Judge Orrick did not allow the jury to view any of the undercover videos during the six-week trial.

Latest news is that David Daleiden is suing Vice President Kamala Harris to expose her criminal acts against him and to let America know that her allies were harvesting aborted babies for their organs to sell on the black market. The suit could mean the end of the case against David and the end of the political career of Kamala Harris.

WHO PICKS BIDEN'S CABINET?



Although Pro-life and profreedom advocates called for the U.S. Senate to reject CA Attorney General Xavier Becerra, a radical advocate of abortion and euthanasia, as the leader of the Department of Health and Human Services (HHS), he got the job,

AR GOVERNOR SIGNS NEAR TOTAL ABORTION BAN



Arkansas Governor Asa Hutchinson on March 9 signed into law legislation banning nearly all abortions in the state, a sweeping measure that supporters hope will force the U.S. Supreme Court to revisit *Roe v. Wade*, but opponents vow to block before it takes effect later this year.

The Republican governor had expressed reservations about the bill, which only allows the procedure to save the life of the mother and does not provide exceptions for those impregnated by rape or incest. Arkansas is one of at least 14 states where legislators have proposed near outright abortion bans this year.

Conservatives believe the court is more open to striking down the decision following former President Donald Trump's three appointments to the court.

Hutchinson has signed several major abortion restrictions into law since taking office in 2015, but he had voiced concerns that this bill directly challenges Roe and about the lack of rape and incest exceptions.

OK SENATOR FORCES A LOOK AT REALITY



Senator James Lankford (R-OK) took to the Senate floor in late January for a gripping 20 minute speech...contrasting the anger people feel at parents who thoughtlessly leave their infants in mortally hot cars

with their indifference to the ones who go to abortuaries to have their slightly younger children killed.

After getting his colleagues' attention, Sen Lankford gave the Senate an unforgettable lesson in biology.

"Reproductive care means paying someone in a clinic to reach into a mother's womb with tools and 'pull the arms and legs off a child...so they will bleed to death in the womb...and I don't understand why that's normal, but leaving a child in the backseat of a hot car is a tragedy." The Senator then presented the chamber with a placard with photographs of an unborn child at 24-, 25- and 26-weeks gestation. He continued:

"Some people are afraid to answer the most obvious question: 'Is that a baby?'" He pointed to the face, eyes, nose and chin of the photographed unborn child.

Sen. Lankford also asked the Senators if all children were valuable – or only some? He observed that they could all agree that gold is valuable but not that all children are valuable. He opposed the idea that the value of children lies only in whether or not their mom or dad wants them.

"Parents shouldn't get to decide who's precious and who's medical waste."

Finally he said, "Don't tell me you follow the science wherever it goes, because some facts are obvious, and the science is clear. Is that a child or not? Everything flows from that."

ABORTION AND BREAST CANCER'

An abortion in the early months of pregnancy when estrogen levels are high predisposes a woman to getting breast cancer. In contrast, a full-term pregnancy early in a woman's reproductive life is protective against breast cancer.

A 1995 Harvard University study on over 2,000 women in Greece found a significant 51 percent increased breast cancer risk among women who had an abortion.

A 1994 National Cancer Institute study of over 1,500 women in Washington State found a significant 50 percent increased risk among women who had any abortions. The risk was more than double for women whose abortion (or first abortion) took placebefore age 18 or over age 30. Source: YOU HAVE A RIGHT TO KNOW

ABORTION ACTIVISTS DISRUPT MASS IN OHIO

On March 10 a group of pro-abortion activists who stormed St.Joseph Cathedral in Columbus, OH, disrupting a pro-life Mass are facing prosecution after being charged by police last month.

During the Respect Life Mass, held on the anniversary of Roe v. Wade and presided over by Bishop Robert Brennan, eight activists interrupted the Bishop's homily as they rushed into the Cathedral and then paraded around the pews before reaching the altar, displaying posters with messages that read: "Fund abortion, not cops," and "Abortion on demand, end Hyde now."

The mostly female group chanted, "Two, four, six, eight, this Church teaches hate," as they marched around the church before being confronted by police and diocesan staff members, who were trying to escort the protestors out. Even after the group had been successfully ushered outside the cathedral, some of them could still be heard inside screaming insults at the congregation, including, "Jesus hates you," and "If hell is real, you can burn in it."

Some of the approximately 200 Mass-goers were visibly shaken and disturbed by the actions of the activists. A number of children were in attendance, and some were seen crying.

Although no arrests were made at the time, of the eightmember group, four had charges filed against them on February 18. Jordyn Close and Mason Hickman, both 24, along wit Michelle Davis, 39, have been charged with criminal trespass and disorderly behavior. They will face pre-trial hearings in March and April. The fourth defendant, Anne Morrice, 35, also faces a more serious misdemeanor charge of criminal damage, in addition to the charges filed against her associates. Morriss is to be brought before the court on March 19.
