AMERICAN LIFE LEAGUE LEADER, PAUL BROWN

His wife, Judy, will tell you that politics was in his blood. Paul and Judy were an unbeatable team when it came to promoting the best pro-life candidates in the highest elected offices in the U.S.

Paul founded LAPAC (Life Amend-ment Political Action Committee, a PAC that supported only NO-EXCEPTIONS candidates. These were the men and women who, when elected, really made a difference for babies in danger of death by abortion. Paul died at the close of 2021.

FOUNDER OF STOPP, FOE OF PP, JIM SEDLAK CAME TO PGH

In 1993, Jim was identified by PP as one of the 15 "most active" fighters against PP sex ed programs. At that time he was director of STOPP (Stop PP Intl.). PP featured Jim in two segments of its anti-life film Unholy Alliance. He was often called to provide commentary on news programs because he was always well-versed and accurate. In 1998 STOPP merged with ALL.

Jim was tireless in his campaign for the right-to-life for all. He died on Jan. 10, 2022.

A STORY TOO GOOD TO MISS (FROM THE BIRTHRIGHT NEWSLETTER)

Mommy E's and Baby A's Story: This time last year, Mommy E. was keeping constant vigil beside Baby A's incubator. In fact, the Neo Natal ICU at Children's Hospital is where she lived for 6 months, as her precious baby fought for her life. Just a few weeks earlier, Mommy E. was transported to Magee Hospital where Baby A was delivered at 24 weeks, weighing only 1 lb.4oz. E was an epileptic, who was badly battered by her mentally ill husband, causing her to have a seizure and go into premature labor. Unfazed by broken ribs, a broken jaw, and post-surgical stitches, mom kept prayerful watch, sleeping in a chair, next to her baby day and night! With the prayers of the pro-life community of Pittsburgh and the support channeled through Birthright, Baby A miraculously survived multiple cardiac arrests, repeated episodes of respiratory distress, and several open heart surgeries! There is no doubt in Mommy A's mind that beautiful Baby A is alive (and well) because of prayer.

The story, however, didn't end there. While staying at the hospital, it was necessary for E. to attend court to tend to the domestic abuse charges faced by her mentally ill husband. While waiting at the bus stop, she had an Epileptic seizure and was dragged by thugs into an alley where she was sexually assaulted while unconscious. The rapists were eventually found and charged, thanks to a security camera which caught the crime on tape. It was only shortly thereafter that E. was faced with the awareness that she had conceived a child. Needless to say, E. was overwhelmed by the reality of another baby when Baby A was not even gestationally 35 weeks old. "I didn't know how I was going to do this all on my own," she said. "I am married; I never planned to be a single mom!" Traumatized by the assault, E. sought the assistance of PARR (Pittsburgh Action Against Rape) and bravely continues to recover from this and past traumas.

However, the story continues. With the encouragement of Birthright, Mommy E. faced her fear and bravely chose life for this new baby. Although tremendously challenged, she persevered. With Baby A. in tow, E. began prenatal care at Magee. Referred by her OB to a Geneticist, E. obediently made an appointment. It was from that office that she placed a desperate call to Birthright where she told Regina of the Dr.'s insistence that she abort! Having been told this during her previous pregnancy with Baby A., Regina reminded E. of her own mind and heart which did not submit to coercion then, and would not do so now. The end result? A beautiful, healthy perfect newborn baby sister A! (Both children have names that begin with A.)

MAGEE PROJECT Meredith Parente

The Magee Project wraps up this season of signing up to pray with the start of 40 Days for Life.

LIGHT AT THE END OF THE TUNNEL?

You must be cautious in making assumptions based on oral arguments at the Supreme Court, but for those of us dedicated to the sanctity of life, it's hard not to be hopeful after today's arguments in *Dobbs v. Jackson Women's Health*, the most serious challenge to *Roe v. Wade* in decades.

A decision isn't expected until summer, but judging from the frantic reactions of *CNN* and the *Huffington Post*, I guarantee you that those who have profited from the stack of infant corpses will not sleep well tonight.

Few cases in the Court's history have had such a negative impact on the U.S. as *Roe v*. *Wade*. That case took a whole class of American citizens, our unborn children, and declared they had no rights we were bound to respect.

Like the infamous *Dred Scott* decision that legalized slavery when it declared that black Americans had no rights we were bound to respect, *Roe v. Wade* treated unborn children like Styrofoam cups to be discarded at will. Since January 1973 more than 63 million children (see previous article) have died. Both were wrong!

Sadly (did you know?) America is among just seven countries in the entire world that permit abortion on demand. We're on the fringe of international law, and today's pro-abortion legal regime is on the fringe of American public opinion. The overwhelming majority of Americans oppose abortion-on-demand.

Progressives love to chant, "Follow the science." Well, the pro-abortion left is not following science. Basic biology tells us that life begins at conception. Advanced ultrasounds give us a window into the womb. We know more about the humanity of the unborn child than we did in 1973, especially the child's ability to feel pain. Doctors now operate on babies in the womb; is the mother the patient? No, it's the child, because there are obviously two people involved. Abortion is a wrong, not a right.

WHAT THE ABORTION INDUSTRY DOESN'T WANT YOU TO KNOW

Unethical and potentially illegal fetal organ harvesting is occurring at the U. of Pittsburgh and its medical center. The report came from a panel organized by the PA Family Council and held at First Trinity Evangelical Lutheran Church, downtown.

The U. of Pittsburgh, a self-styled fetal tissue "hub" made headlines recently for experiments which grafted fetal scalps onto the backs of lab rats with funding from Dr. Anthony Fauci's National Institute of Allergy and Infectious Diseases.

Panelist David Daleiden, founder of the Center for Medical Progress, argued that the fetal experiments and organ harvesting at the U. of Pgh. Might be conducted on live fetuses.

Daleiden's organization obtained a grant application to the National Institute for Health (NIH) in which Pitt asked for federal tax dollars to fund its experiments on aborted babies.

In its grant application, Pitt promised it would minimize "ischemia time...to ensure the highest quality biological specimens" in its fetal experimentation. Daleiden explained that ischemia is typically defined as the lack of blood circulation to the organs. If the fetus has died and the heart has stopped pumping blood, then ischemia has begun.

He said Pitt could this be indicating that the blood is still pumping and the fetus is alive as its scientists harvest the organs. Dr. Ronna Jurow, an OB-GYN who previously worked at PP, agreed with Daleiden's assessment and told FOX News, "there's no question" the fetus would be alive during the organ harvesting. The U. of Pgh. Has denied this claim.

Daleiden argued that the U. of Pgh. Also uses racial quotas in these experiments.

In its grant application, Pitt specified that its fetal experiments should use 50% minority fetuses, including 25% black fetuses. Allegheny County is around 80% white and 13% black.

Former PA Superior Court Judge Cheryl Allen argued that these numbers aren't coincidental. True to the mission of PP founder Margaret Sanger, abortion providers routinely target the black community. She announced that a jaw-dropping 40% of all black babies in the state of PA are aborted.

Panelist Cecily Routman, president of the Jewish Pro-Life Foundation, argued that the experiments on babies occurring at Pitt are similar to medical experiments conducted on Jews in Nazi Germany. She recalled that Jews would be awake while Nazi doctors at Auschwitz experimented on them and extracted their organs—without anesthesia. Routman pointed out that the country who 75 years ago defeated the Nazis is conducting similar experiments on defenseless babies.

Daleiden said that these experiments are conducted under the advisement of PP employees. He said that a medical director of PP, Dr. Beatrice Chen, is an employee of both the university and the university's medical center.

Chen is listed as a vice chair of the Institutional Review Board at the university, acting as an ombudsman overseeing Pitt's fetal studies. Chen is a director of family planning at U. of Pgh. Medical Center Magee-Women's Hospital.

Daleiden argued that federal law prohibits collaboration between the researchers and the institution that performs the abortions. Pitt may also be in violation of NIH, NIAID, and DHHS statutes that prohibit experimentation on live fetuses.

Pitt denies that any such "procurement relationship" exists between the university and PP.

The NIH and the NIAID have together awarded Pitt close to \$2 million to fund projects that included grafting fetal scalps onto rats. In addition, HHS funded Pitt's GenitoUrinary Development Molecular Anatomy Project (GUDMAP), where university researchers operated from a tissue bank with organs of aborted fetuses to the tune of at least \$2.7 million.

Pitt denied that it has broken any state or federal law, but it has hired a law firm to investigate its own practices.

In response to the reports on Pitt's experiments, nearly 100 senators and House members sent a letter to the NIH, HHS and Department of Justice demanding the release of primary documents detailing methods used to procure fetal tissue for Pitt's experimental projects.

The letter demanded to know whether Pitt was breaking federal law by harvesting organs from "babies who were old enough to live outside the womb." The letter also called into question whether Pitt broke fetal tissue trafficking and partial birth abortion laws.

We live in a world where precious human lives, created by our loving Father, are degraded and used as commodities to be bought, sold, tortured and killed to satisfy scientific hunger for "progress."

The pro-life men and women who investigate and bring these horrors to light are the same volunteers we see on the sidewalk in front of Planned Parenthood, kneeling or standing in prayer, and offering Mothers all the assistance they need to keep their babies safe from abortion.

Please pray for the mothers and the volunteers. And please, let us never stop praying for those who make their living as you have read in this article

BIDEN'S NOMINEE IS PRO-ABORTION FOR SURE

We have one copy, still in the wrapper, of the movie that NATIONAL REVIEW called "a true story of love, hope, and redemption."
