WILL ROE V. WADE BE OVERTURNED?

While we wait and pray, pro-lifers around the country are sending messages of hope, while at the same time issuing words of caution. Brian Gibson (Pro-Life Action Ministries, St. Paul, MN) said his "hope has only increased after reading some of the questioning by the justices during oral arguments. He goes on, "...this Mississippi law, which bans abortion after 15 weeks gestation, is a direct challenge to the 1973 Roe v. Wade decision as it is interpreted by the 1992 Planned Parenthood of Southeastern PA v. Casey decision. In order to decide this case, the Supreme Court justices have to review these previous cases. So, yes, Roe v. Wade is on the line."

Butler Chapter, PHL, points out: "Sherif Girgis, an Associate Professor of Law at Notre Dame Law School and a former law clerk to Justice Alito, told LifeNews that he expects the "The Chief Supreme Court to reverse Roe. repeatedly asked if there was a middle ground, and no one produced one. On the contrary, the lawyers for the Biden administration and the clinics repeatedly rejected any middle ground. Justice Kavanaugh repeatedly signaled that he thinks abortion is entirely for the states to decide. Justice Barrett showed that the availability of adoption undercuts many of the arguments for a constitutional abortion right."

From the left, an editorial in THE NATION shows anger, fear and determination to encourage women who have had abortions to share their stories and build a mass movement in favor of abortion rights. Jennifer Holland, (U. of OK) says anti-abortion activists went into churches, sex ed classrooms and Sunday Schools, using tiny plastic fetal models to imagine fetal life as essential to their own sense of self. She encourages women to tell their abortion story, closing out their rally with, "Everyone loves someone who has had an abortion." (Call PCUC for this article).

JUDICIAL WATCH QUOTES LIFENEWS ABOUT PITT

"In The Media," (April 2022) shares the following from the Feb. 4, 2022 *LifeNews:*

Recently, the University of Pittsburgh continued to defend its gruesome experiments involving implanting aborted babies' scalps onto rodents and other research with aborted baby parts, citing an new investigation that found its reseach is "fully compliant" with state and federal laws.

The university commissioned the outside investigation last year after *Judicial Watch* and the Center for Medical Progress exposed evidence of babies potentially being born alive in abortions and other disturbing practices at the university. Evidence came from documents obtained from the U.S. Dept. of Health and Human Services through a Freedom of Information Act Request.

State and federal lawmakers, pro-life organizations and others have been calling for an investigation of the university for months ever since the Center for Medical Progress and *Judicial Watch* released their FOIA documents.

PA SUPREMES WANT TAXPAYERS TO FOOT BILL FOR ABORTIONS

Earlier this year, a case filed by Planned Parenthood, Allegheny Reproductive Services and the PA abortion cartel was dismissed by Commonweath Court because of a lack of standing. There is NOTHING in the PA Constitution that would **require** taxpayer funding of abortion. Undeterred, the PA abortion industry appealed to the PA Supreme Court.

Our current PA Supreme Court, with a very liberal, progressive makeup, could very well grant the abortion industry's wishes. If that happens, virtually all of our current pro-life laws and policies are likely to be wiped out.

What we need in PA is an amendment to the PA Constitution that says WE DO NOT PAY FOR ABORTIONS! To do that will take three very vital steps, the 1. Careful DRAFTING, 2. Passage by a simple MAJORITY of both Senate and House in TWO SUCCESSIVE TERMS and 3. Ratification at the ballot box in the next election. Right now, PRAYER is our best tool. NIKKI BRUNI DEFENDS LIFE

Buffer zones (sometimes called "bubble zones") are those hateful state and local lasws that create areas in front of abortion facilities into which anyone can go and say what they want, except pro-lifers. Apparently, states and localities consider prayer more dangerous than COVID as most buffer zones extend from 8-150 feet, while COVID restrictions are 6 feet. Go figure.

These are actually zones of censorship, and for the most part, the courts agree and roundly strike down buffer zones as direct violations of the 1st Amendment and, frankly, as un-American. "Abortion clinic buffer zone laws impose serious burdens on core speech rights." (*McCullen v. Coakley, 134 S.Ct. 2518, 2535 (2014)*. Even the liberal justices typically agree. After all, if our pro-life speech is banned, who's next?

40 Days for Life filed two Amicii briefs in two separate, recent cases: *Price v. Chicago* and *Bruni v. City of Pittsburgh*. (Nikki Bruni is the lead plaintiff, an iconic 40 Days for Life leader and 2021 Leader of the Year).

Chicago modeled its 8-foot floating buffer zone after one of the only surviving buffer zones in the U.S. It was smart of them to use a statute that was upheld earlier by the Court, and it worked.

In *Bruni*, Pittsburgh's 15-foot zone outside of any hospital or health care facility was determined to be valid, even though it even bans prayer: "[N]o person or persons shall knowingly congregate, patrol, picket or demonstrate" in the prescribed zone. *Pittsburgh*, *Pa.*, *Code 623.04 (2005)*.

Sidewalk Advocates, who are trained to offer assistance to women headed for the doors of Planned Parenthood in downtown Pittsburgh, do not wear any sign that they are pro-life, but their conversations with women (and men) planning to pay to have their child killed can lead to a change of heart and mind. They can walk beside a prospective "customer" right up to the doors.

SD GOV. KRISTI NOEM SIGNS TWO PRO-LIFE BILLS TO HELP WOMEN



It's progress toward success. First, a law that makes it illegal to coerce anyone to get an abortion. Those found guilty will be charged with a Class B felony. Second, a prohibition on the distribution of abortion pills via telemedicine. Instead, it requires

women who want a chemical abortion to make three in-person visits to a doctor: one to take the first abortion pill, another appointment several days later to take the second drug in the abortion-pill regimen, and a third visit two weeks later to confirm that the abortion was complete. The second law came under attack by the abortion lobby when Noem issued an executive order, but now it is law

MOST MEDIA OUTLETS WON'T TELL YOU WHAT WHO PROPOSES

In the first week of April the World Health Organization (WHO) unleashed a 210-page set of guidelines that calls abortion for any reason—right up until the moment of birth—an international human right. The WHO document recommends 'full decriminalization of abortion' and the scrapping of laws and regulations that 'prohibit abortion based on gestational limits' and 'restrict abortion' on any grounds.

Only three percent of countries allow this kind of tragedy. The countries include North Korea, China and the United States.
