### ABORTION COMPLICATIONS From Bill Donohue @ Catholic League

Most of the mainstream media is in the tank

with pro-abortion activists, which explains their reluctance to report on abortion complications.

They will not tell you that in 2020 there were 620,327 abortions in the U.S. Also, roughly 2 % of abortions involve complications. So, in about 12,400 cases, there were complications.

Also, 2020 marked the first time that a majority of abortions (53%) involved pills.

Dr. Ingrid Skop, OB-GYN, is a senior fellow and director of medical affairs at the Charlotte Lozier Institute. She is concerned about the decision by the FDA to remove all restrictions on obtaining the abortion pill. Women do not have to see a doctor in-person to be prescribed pills.

The regimen approved by the FDA consists of two pills. Mifepristone blocks the progesterone receptor, so it cuts off hormonal support and kills the baby. It's followed in 24-48 hours by misoprostol, which induces contractions and causes the baby to be expressed. In about one out of 20 times it will not express all the tissue, and the mother will need surgery to complete the abortion.

Pres. Biden took away the in-person requirements for the abortion pill. Dr. Skop explains: "...there's no physical exam, no ultrasound to be sure the gestational age is correct, to be sure the pregnancy is not in the fallopian tube where it could rupture. There are no safeguards to make sure a woman is not being coerced into abortion, no labs to see if she has an Rh-neg. blood type and needs RhoGam to prevent future pregnancy complications."

### **HEARTBEAT BILL INTRODUCED**

PA's Mike Kelly has introduced The Heartbeat Bill, HR-175, in Congress with 63 cosponsors, all Republicans. It has been referred to the Judiciary Committee.

Though it reportedly has an unfortunate provision permitting the sacrifice of babies conceived in a sex crime, HR-175 would protect the vast majority of babies who would otherwise be targeted for abortion. It provides that abortion cannot legally be permitted after a developing baby's heartbeat is detected, at roughly six weeks gestation.

The bill serves as a deterrent not only by subjecting abortionists to criminal penalties but also by the educational value of discussions and debates during its consideration. The concept that a heartbeat can be detected almost at the same time the mother acknowledges her pregnancy is in itself a strong note of persuasion that a human life is at stake.

## **PP \$250,000 FOR WHAT?**

# PA DEMOCRATS PUSH TO PUT ABORTION INTO PA CONSTITUTION

Pennsylvania's so-called "Women's Health" Caucus, which operates under the guise of women's healthcare but primarily focuses on promoting abortion, held a press conference on March 1 that announced their push for adding abortion to our state constitution, impacting every current limit on abortion in our Commonwealth.

"Abortion has sadly become one of the top issues for the Democratic party, an issue which only serves the interests and the pockets of the abortion industry, not women in Pennsylvania," commented Alexis Sneller of the PA Family Institute. "Not only does this Democrat-led caucus want to see abortions increase in our Commonwealth, but they want to jeopardize current state laws like the PA Abortion Control Act and every limit on abortion in PA in order to force unrestricted, taxpayer-funded abortion in our Commonwealth."

The so-called "Reproductive Rights Amendment" is a proposed amendment to enshrine abortion in the PA Constitution, which would jeopardize every current limit on abortion, including taxpayer funding of abortion, the 24-week (sixmonth) gestational limit, and the 24-hour waiting period. This harmful bill has yet to be formally introduced, but a co-sponsor memo is currently being circulated by Rep. Danielle Friel Otten (D-Chester) and Rep. Liz Hanbidge (D-Montgomery).

The "Women's Health" Caucus revealed a mission statement stating they are bipartisan, yet the 52 members <u>currently listed</u> on their website are all Democrat. This is the same caucus that held multiple legislative hearings last session attacking pregnancy help centers, spreading misinformation about their vital services.
