customer has ingested it. HR-983, the "Second Chance at Life Act," has 35 sponsors. It has been assigned to the House Committee on Energy and Commerce.

CROSSROADS PREGNANCY CENTER

It's helpful to know what pregnancy support centers outside our area are doing to improve the numbers of mothers and babies they can help. **Crossroads Pregnancy Center** did some online marketing specifically to women who are Abortion Vulnerable or Abortion Determined. Statistics show that 2,963 people clicked on their ads and they answered areound 332 calls and texts directly from those ads.

When Crossroads saw the results of their online marketing, they prayed for God's wisdon and with God's help they opened a new office in Altoona.

As they saw growth coming, they added new staff, including a second nurse. They feel they are now equipped and ready for even more growth.

By July of 2022, they had done 60 ultrasounds in their four offices. This was three times as many as they had between January and July of the previous year. With the new office, they anticipate that next year's numbers will be even higher.

Please pray that women will be helped and babies' lives saved in the days ahead.

VERMONT WILL KILL OUTSIDERS

THE ABORTION PILL

The Supreme Court is allowing continued sales of the dangerous abortion pill that kills babies and has killed and injured women.

The vote was 7-2, with Justices Clarence Thomas and Samuel Alito dissenting.

The nation's highest court ruled in an unsigned order that the abortion drug mifepristone can continue being sold as is nationwide—turning back an effort by doctors to block sales or at least stop mail-order abortions that put women's health at risk. ONLY 26 STATES HAVE PROTECTIONS

Susan B. Anthony Pro-Life America commissioned a report on how individual states make some effort to protect the lives of preborn babies. We can send you a copy of the report as it appears on a map of the states, but we have a long way to go if we want to say we are winning the battle for the lives of our brothers and sisters.

17 states have 9-month protections

- 4 states have a heartbeat bill in effect
- 2 states have 12 week protection in effect
- state has 15 week pain capable protection
 Arizona has strong protections stalled
 in state courts
 All other states (26) have few or no life-

saving protections. PA is in this group.

ARE YOU REGISTERED TO VOTE?

Unless you are registered to vote, anything you say, all of your opinions, and no matter how you feel about the candidates is just hot air.

Every county in Pennsylvania has an Elections Department. You can register in person, or on-line or the department will send you an application, and your application must be received by the end of the day 15 days before election day.

MARK HOUCK AND SON SHARE EXPERIENCE ON THE SIDEWALK

It's another story of a pro-lifer being assaulted and the person who defends him being arrested and taken to jail.

Mark Houck and his son, Mark Jr. went to do a four-hour vigil at PP in Philadelphia. As they prayed, the younger Houck was accosted by a deathscort on a street corner. After the elder Houck insisted that the deathscort stop harassing his son, the deathscort still remained in the boy's personal space, so the father protected his son by pushing away the boy's verbal assailant.

The back and forth of the case wherein the deathscort pressed charges against Houck continued for almost a year. The next chapter in the case ended on September 21, 2022, when storm troopers descended on the Houck residence, announcing that they were FBI. There were eight agents, dressed in body armor with state troopers behind them with weapons pointed at them.

The case is still not over. The Houcks intend to testify before Congress to seek justice for the way they were treated. They will sue PP.

We shall keep you posted. We ask you to keep the Houcks in your prayers.

USCCB REBUKES LAWMAKERS WHO DEFEND ABORTION



The United States Conference of Catholic Bishops (USCCB) has denounced the thirty-one Democratic members of Congress who <u>claimed</u> on June 24, the one-year anniversary of

the overturning of *Roe v. Wade*, that their religious beliefs compel them to defend abortion.

"Members of Congress who recently invoked teachings of the Catholic faith itself as justifying abortion or supporting a supposed right to abortion grievously distort the faith. It is wrong and incoherent to claim that the taking of innocent human life at its most vulnerable state can ever be consistent with the values of supporting the dignity and wellbeing of those in need."

The statement was issued by USCCB President Archbishop Timothy P. Broglio, Arlington Bishop Michael F. Burbridge, Chairman of the USCCB's Committee on Pro-life Activities, and Bishop Daniel E. Flores, Chairman of the USCCB's Committee on Doctrine.

Among the lawmakers who added their name to the "Renewed Statement of Principles" include former House Speaker Nancy Pelosi, Michigan Representative Debbie Dingell, Texas Representative Joaquin Castro and ultraprogressive Connecticut Representative Rosa L. DeLauro, who played a leading role in drafting the document. DeLauro was widely panned by conservatives for invoking her Catholic beliefs to justify her heretical views.

KIDNEY REMOVAL FROM CHINESE INFANTS RINGS ALARM FOR THE WORLD

In Western countries, recipients of neonatal kidney transplants are usually very young infant, but one of the recipients was 34 years old and another was 25, said Zain Khalpey, associate professor of Surgery, Medical Imaging, Physiological Sciences, and Biomedical Engineering at the University of Arizona.

"It is untested, unethical. If it's going into another child, sure. If it's going into an adult, I'm questioning it. So, the practice of using a newborn baby is difficult to accept because they don't have a say," Khalpey told the Epoch Times on March 4.

Khalpey questions whether doctors at Shanghai's Renji Hospital can complete matching tests within 3-5 days of a baby's birth. He said it can be assumed that testing was carried out using amniotic fluid extracted while the baby was still in the mother's womb. It can take weeks to crossmatch a donor after blood and tissue typing and find a compatible recipient.

Let us pray for the babies, mothers and all the people of China as they endure a party of rulers who have no regard for the sanctity of the lives of the people they control.
